

## COLLEGE ENROLLMENT OPTION

This fund is a member of the BlackRock College Advantage Plan\*

### Investment Approach

This portfolio is designed for a Beneficiary who is about to enroll in college or who is already enrolled in college. This Investment Option emphasizes investments in fixed-income investments and money-market investments, with a moderate allocation to equity investments. The allocation reflects a lower-risk approach in order to seek income and protect principal. This Investment Option has a target allocation of 20% equity investments and 80% fixed income investments.

Enrollment date investment options are designed to fit a particular investment time horizon for the expected college enrollment year of the beneficiary. Asset allocation will change over time according to a predetermined glide path as the fund approaches its target date. Asset mix becomes more conservative prior to enrollment, as time elapses.

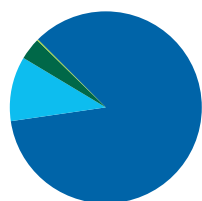

The Morningstar Medalist Rating™ is the summary expression of Morningstar's forward-looking analysis of investment strategies as offered via specific vehicles using a rating scale of Gold, Silver, Bronze, Neutral, and Negative. The Medalist Ratings indicate which investments Morningstar believes are likely to outperform a relevant index or peer group average on a risk-adjusted basis over time.
