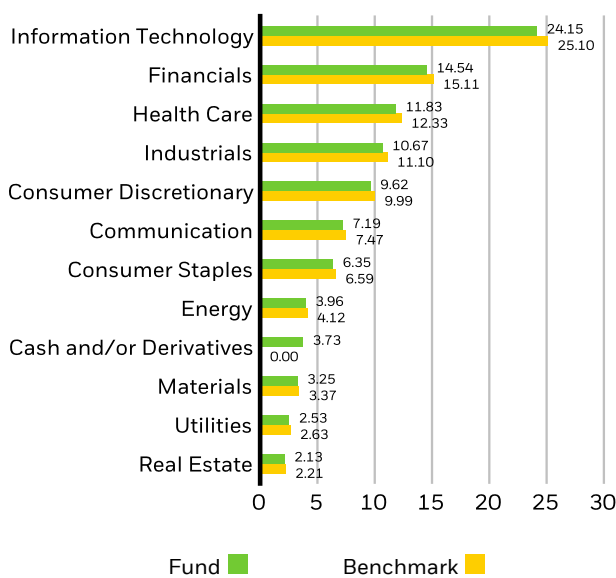

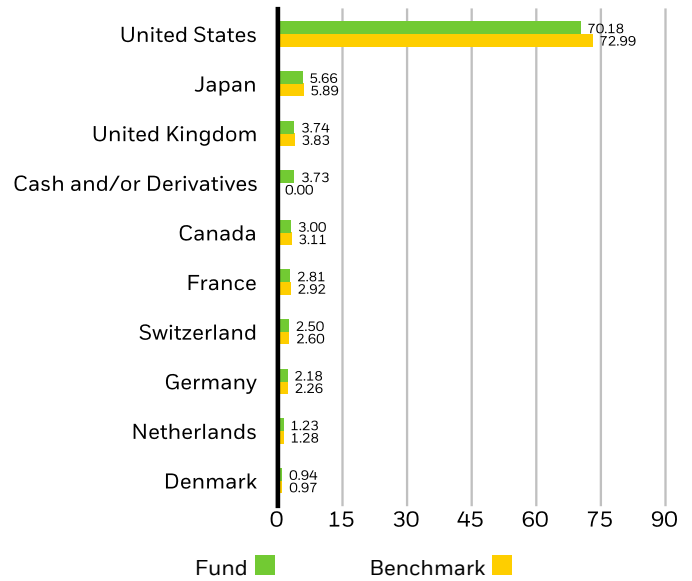

SECTOR BREAKDOWN (%)



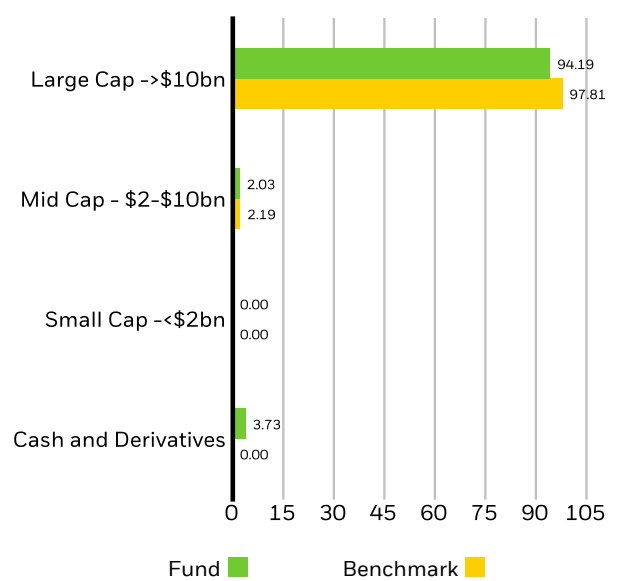
