- an Australian public company; and
- the responsible entity of managed investment schemes registered with the Australian Securities and Investments Commission (**BlackRock Funds**).

BlackRock provides this notice pursuant to its obligations under Part 1.2AA of the *Corporations Act 2001* (Cth) and related regulations (**Corporations Act**).

From time to time, BlackRock may issue the following documents to its shareholders and unitholders in relation to itself and each BlackRock Fund, respectively:

- documents relating to a shareholder or unitholder meeting;
- documents relating to annual financial reporting (including financial reports, directors' reports and auditor's reports) (**Annual Reports**); and
- other documents prescribed under the Corporations Act for the purposes of this notice,

(collectively, **Notifiable Documents**).

For the purposes of the Corporations Act, BlackRock gives notice to its shareholders and the unitholders of each Fund of their rights:

- to elect or request to be sent Notifiable Documents in physical or electronic form; and
- to elect not to receive the Annual Reports and any other documents prescribed by the Corporations Act.
