### FUND OVERVIEW

The Fund aims to generate income and a reasonable degree of liquidity consistent with low volatility of capital, through the maintenance of a portfolio of High Credit Quality fixed income securities (such as bonds) and money market instruments (MMIs) (i.e. debt securities with short term maturities) Liquidity means assets can easily be bought or sold in normal market conditions. Money invested in the Fund is not protected or guaranteed. The investment manager will take into account certain environmental social and governance criteria when selecting investments, as detailed in the Fund's prospectus. 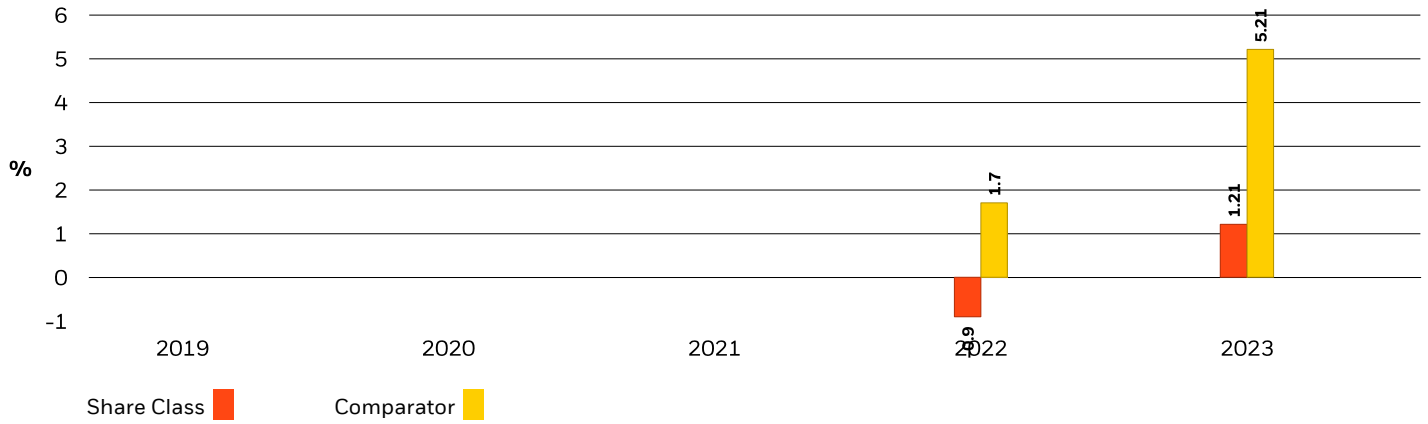

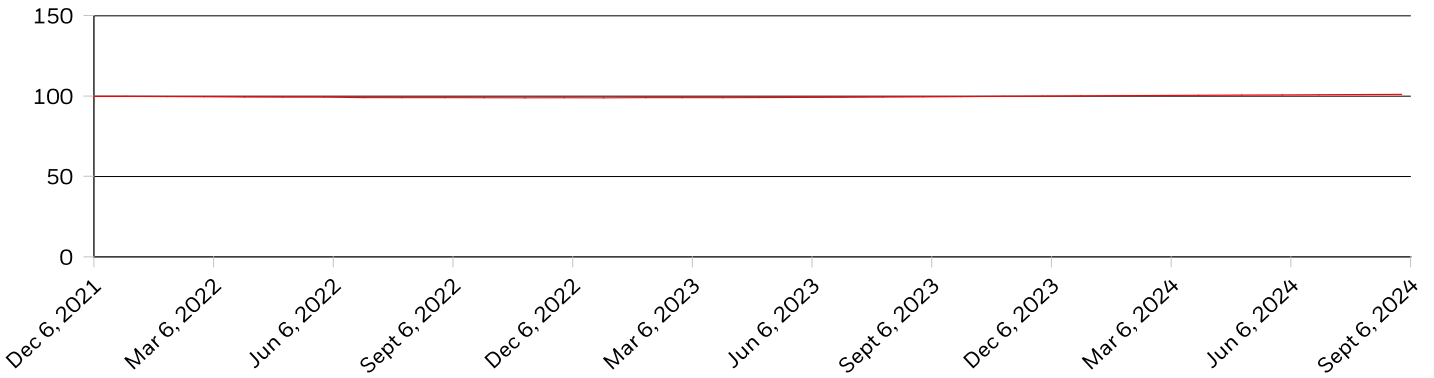

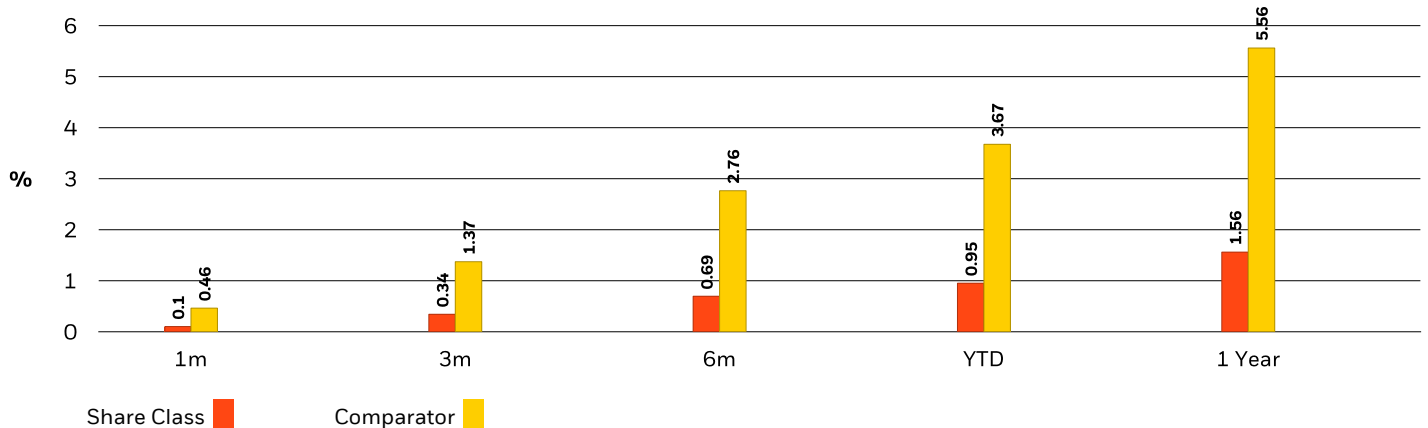
**CALENDAR YEAR PERFORMANCE**

**CUMULATIVE & ANNUALIZED PERFORMANCE**



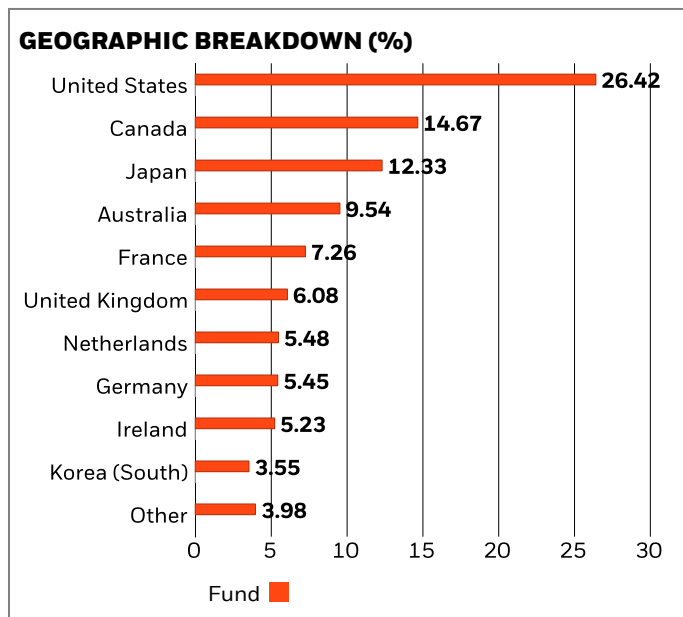
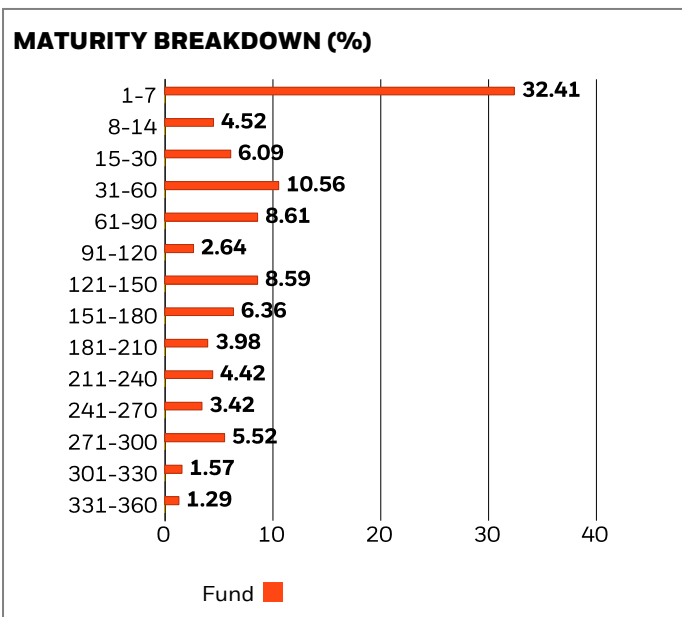

**Weighted Average Life:** Measurement of a fund's sensitivity to a deteriorating credit environment; potential credit spread changes or tightening liquidity conditions. The WAL calculation is based on a security's stated final maturity date or, when relevant, the date of the demand feature when the fund may receive payment of principal and interest.
