FUND OVERVIEW

The Fund aims to generate income and a reasonable degree of liquidity consistent with low volatility of capital, through the maintenance of a portfolio of High Credit Quality fixed income securities (such as bonds) and money market instruments (MMIs) (i.e. debt securities with short term maturities) Liquidity means assets can easily be bought or sold in normal market conditions. Money invested in the Fund is not protected or guaranteed. The investment manager will take into account certain environmental social and governance criteria when selecting investments, as detailed in the Fund's prospectus. 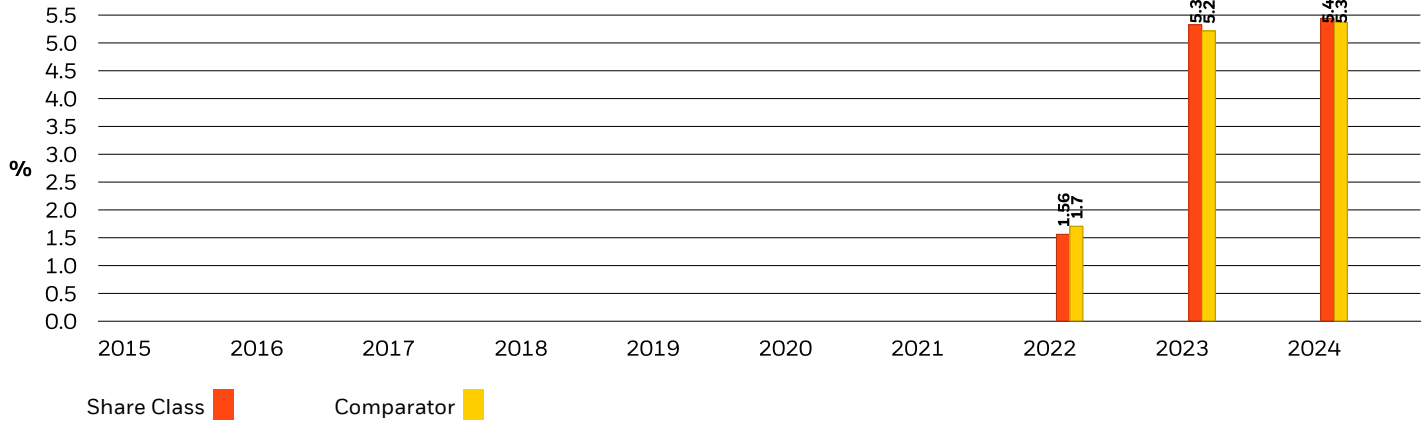

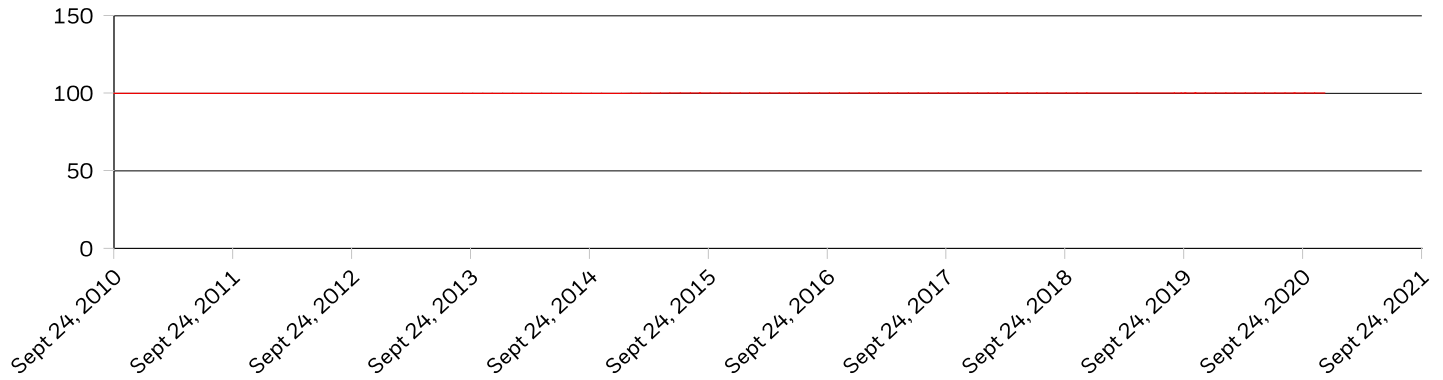

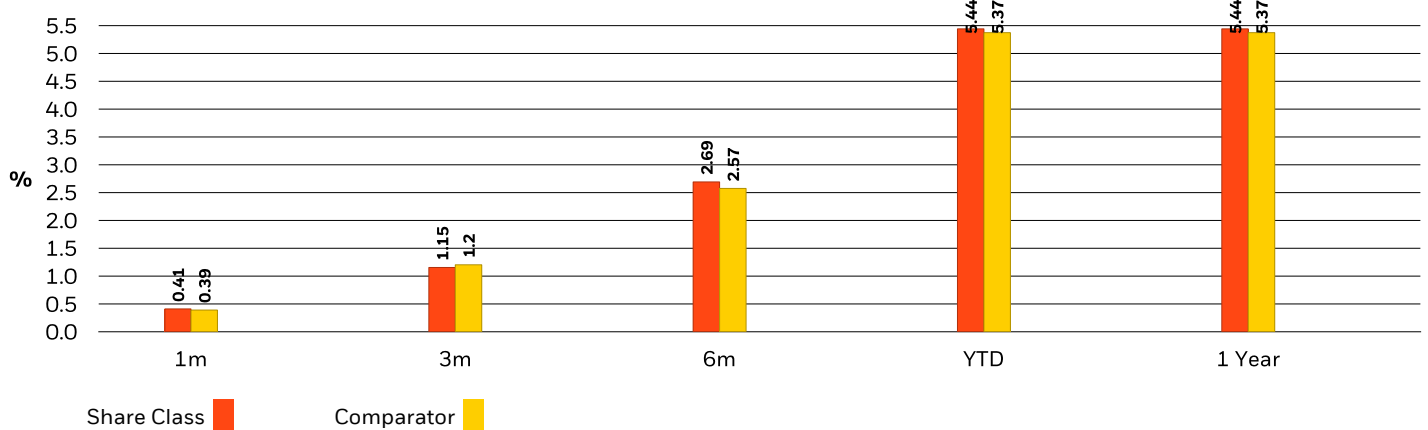
CALENDAR YEAR PERFORMANCE

CUMULATIVE & ANNUALIZED PERFORMANCE



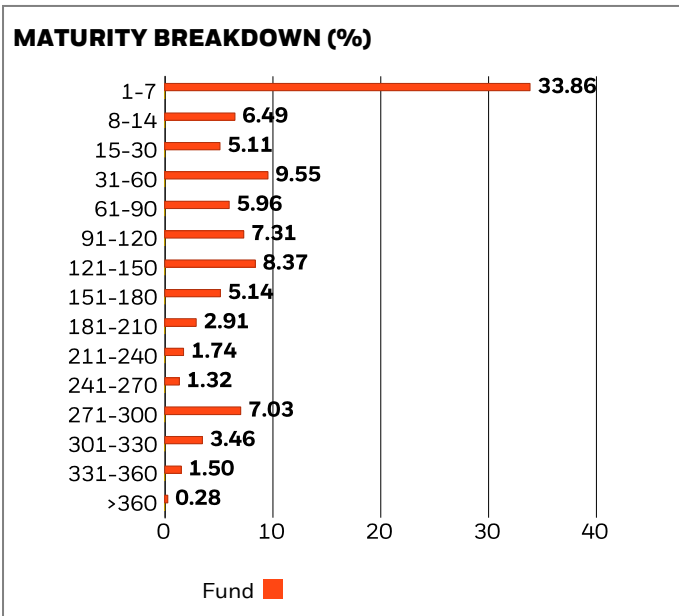
