BlackRock Launches iShares Robotics and Artificial Intelligence ETF

One ETF Option to Capture Two Exciting Investment Themes

June 28, 2018, New York – As robotics and artificial intelligence (AI) continue to grow as investment themes within the broader technology landscape, BlackRock (NYSE: BLK) is expanding its suite of thematic iShares ETFs. With the launch of iShares Robotics and Artificial Intelligence ETF (IRBO), investors now have the ability to access companies that are creating rapid advancements across a wide variety of industries.

"Secular trends in technology aren't confined to any one industry or geography, and that is particularly true for the broad-sweeping influence we see with robotics and AI driving innovation across all industries today," says Mark Alberici, head of iShares product innovation at BlackRock. "Investors looking to capture these long-term technology shifts now have a targeted solution available that reaches around the globe to offer exposure to leaders in robotics and AI."

IRBO seeks to track an index that utilizes a rule-based security selection process to target the Robotics and Al value chain. A two-in-one solution, IRBO offers investors access to two innovative and interconnected themes in an efficient manner. As the components of the underlying index are equally weighted, IRBO is not dominated by mega cap names and provides equal-weighted access to companies specializing in innovations across Robotics and Al.

Given the global, long-term nature of the trends underpinning IRBO, investors may consider using the ETF as a strategic tilt in portfolios to:

- Invest in disruptive change: Exposure to companies at the forefront of robotics and Al
 innovation
- 2. **Harness robotics and Al value chain**: Access to companies globally with exposure to the robotics and Al themes
- 3. **Seek long-term growth**: Secular growth potential by investing in innovative robotics and Al companies with the potential to shape the global economic future

IRBO seeks to track the investment results of the NYSE FactSet Global Robotics and Artificial Intelligence Index, composed of developed and emerging market companies that could benefit from the long-term growth and innovation in robotics technologies and artificial intelligence.

IRBO is the second thematic launch of the year, following the launch of the iShares U.S. Infrastructure ETF (IFRA) in April. IRBO has an expense ratio of 0.47% and began trading today on the NYSE Arca exchange.
