

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

iShares Lithium & Battery Producers UCITS ETF (the "Fund"), USD Accu (the "Share Class"), ISIN: IE000WDG5795, is authorised in Ireland and manufactured by BlackRock Asset Management Ireland Limited (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Ireland and regulated by the Central Bank of Ireland (the "CBI") and the CBI is responsible for supervising the Manager in relation to this Key Information Document.

Type: The Fund is a sub-fund of iShares IV plc, an umbrella company incorporated in Ireland, authorised by the Central Bank of Ireland as a Undertaking for Collective Investment in Transferable Securities ("UCITS"). The Fund is a UCITS exchange-traded fund, a UCITS ETF.

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Share Class aims to achieve a return on your investment, through a combination of capital growth and income on the Fund's assets, which reflects the return of the STOXX Global Lithium and Battery Producers Index, the Fund's benchmark index (Index).
- The Share Class, via the Fund, is passively managed and aims to invest so far as possible and practicable in the equity securities (e.g. shares) that make up the Index.
- The Index reflects the performance of a sub-set of equity securities of eligible developed and emerging market countries within STOXX World AC All Cap Index or the STOXX Global Lithium Universe Index (the "Underlying Indices") with significant exposure to the lithium industry through lithium miners, compounds manufacturers and lithium battery producers (the "Lithium Industry Theme").
- Companies included in the Index must (i) have a free-float market capitalization greater than USD \$100 million; (ii) have a 3-month average daily traded volume equal to or greater than USD \$1 million; (iii) be assigned to one of the eligible tier groups as determined by the index provider.
- Companies are assigned to tier groups depending on how they gain exposure to the Lithium Industry Theme. Inclusion criteria to tier groups 1 and 2 includes revenue, exposure or market share from sectors associated with the Lithium Industry Theme. Tier 3 companies need to have developed patents relevant to lithium batteries and generate sufficient revenue from non-lithium specific battery making sectors.
- The Index is free float market capitalisation weighted and rebalances on an annual basis.
- At each rebalance, companies which are no longer eligible for the Underlying Indices will be removed from the Index. Current constituents of the Index are screened for their involvement in severe ESG controversies and adherence to international norms and principles on a quarterly basis and issuers which are no longer eligible will be removed at the relevant quarter.
- The Fund intends to replicate the Index by holding the equity securities which make up the Index, in similar proportions to it.
- The Fund may also engage in short-term secured lending of its investments to certain eligible third parties to generate additional income to off-set the costs of the Fund.
- The investment manager may use financial derivative instruments for direct investment purposes to help achieve the Fund's investment objectives.
- The price of equity securities fluctuates daily and may be influenced by factors affecting the performance of the individual companies issuing the equities, as well as by daily stock market movements, and broader economic and political developments which in turn may affect the value of your investment.
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is State Street Custodial Services (Ireland) Limited.

- Your shares will be accumulating shares (i.e. income will be included in their value).
- Your shares will be denominated in US Dollar, the Fund's base currency.
- The shares are listed and traded on various stock exchanges. In normal circumstances, only authorised participants may buy and sell shares directly with the Fund. Investors who are not authorised participants (e.g. select financial institutions) can generally only buy or sell the shares on the secondary market (e.g. via a broker on a stock exchange) at the then prevailing market price. The value of the shares are related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below). The prevailing market price at which the shares trade on the secondary market may deviate from the value of the Shares. Indicative net asset value is published on relevant stock exchanges websites.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

Insurance benefits: The Fund does not offer any insurance benefits.

The assets of the Fund are held in safekeeping by its depositary, State Street Custodial Services (Ireland) Limited (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). What are the costs?
