The Directors of iShares III plc (the “**Company**”) wish to advise you of an upcoming change to simplify the name of the Funds, as described below. The change is anticipated to take effect on 27 March 2024 (the “**Effective Date**”).

This change will not effect the manner in which the Funds are managed, nor will it effect the Funds’ operation, performance or costs. You are not required to do anything as a result of this notification.

It is anticipated that the Company’s prospectus (the “Prospectus”) and the Key Investor Information Document (KIID) or Key Information Documents (KID) as applicable for the Funds will be updated on (or around) the Effective Date to reflect the change described in this letter, subject to the approval of the Central Bank of Ireland. The updated Prospectus and KIID/KID (as applicable) will be available on www.ishares.com.
