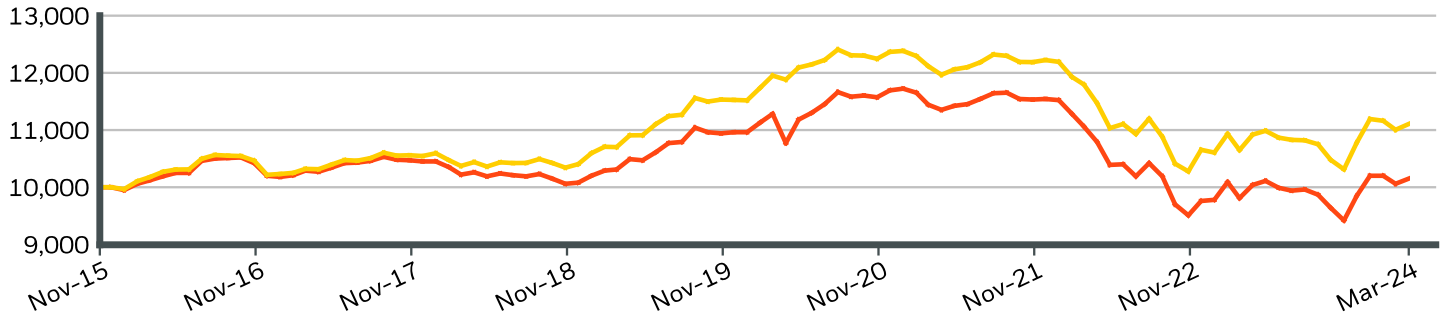

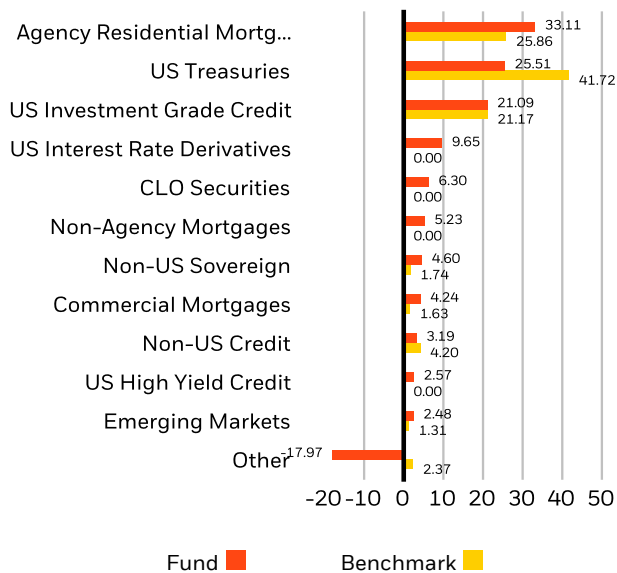

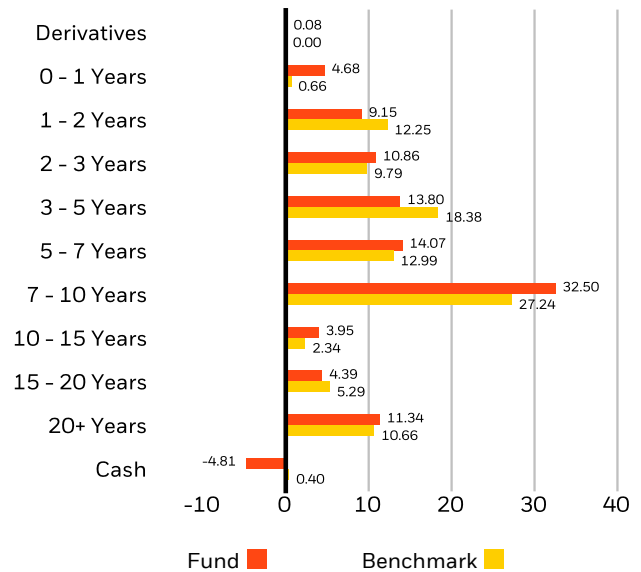

**SECTOR BREAKDOWN (%)**



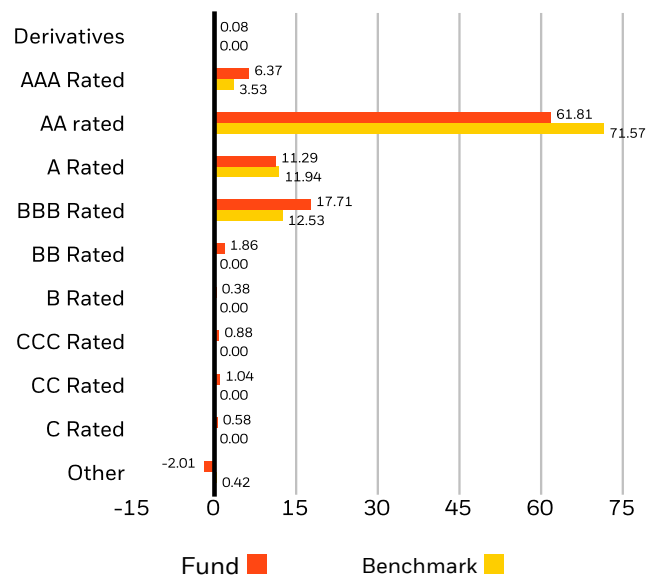
