The Changes will not materially prejudice the existing investors' rights or interests. There will be no change in the fees payable out of the assets of the Sub-Funds as a result of the Changes.

While the Manager, the Trustee and other service providers of the Trust will take appropriate measures to ensure normal operations under severe weather conditions as far as possible to facilitate dealings in a Sub-Fund, in both primary and secondary markets, investors should note that their ability to deal in a Sub-Fund will also depend on the availability of the services of their own service providers. For example, investors who wish to deal in Units listed on the SEHK on a day on which severe weather conditions persist will have to do so through their brokers. Such brokers are independent of the Manager, and it cannot be guaranteed that their services will not be disrupted by severe weather events.
