**Suspension of the calculation of the NAV of BlackRock Global Funds – Emerging Europe Fund**

Reference is made to the notices to shareholders dated 1<sup>st</sup> March 2022, 1<sup>st</sup> April 2022, 29<sup>th</sup> April 2022, 27<sup>th</sup> May 2022, 27<sup>th</sup> June 2022, 27<sup>th</sup> July 2022, 26<sup>th</sup> August 2022, 26<sup>th</sup> September 2022, 26<sup>th</sup> October 2022, 25<sup>th</sup> November 2022, 23<sup>rd</sup> December 2022, 20<sup>th</sup> January 2023, 20<sup>th</sup> February 2023, 20<sup>th</sup> March 2023, 20<sup>th</sup> April 2023, 19<sup>th</sup> May 2023, 19<sup>th</sup> June 2023, 19<sup>th</sup> July 2023, 18<sup>th</sup> August 2023, 18<sup>th</sup> September 2023, 18<sup>th</sup> October 2023, 17<sup>th</sup> November 2023, 15<sup>th</sup> December 2023 and 15<sup>th</sup> January 2024 on the suspension of the valuation (and consequently issues, redemptions and conversions) of all Share Classes of BlackRock Global Funds – Emerging Europe Fund (“the Fund”) with effect from and including 1<sup>st</sup> March 2022 in accordance with the Prospectus and the Articles of Association of BlackRock Global Funds (“BGF”), and the subsequent notice dated 11<sup>th</sup> March 2022 updating you of the status of the suspension.

We wish to notify you that the suspension will remain in place until further notice. The depositary of BGF has been consulted and has no objection to this suspension decision.

Dealing in the Fund continues to be suspended. This means we are not able to accept any requests to buy, switch or redeem shares in the Fund, received after 12:00 pm CET on Monday 28<sup>th</sup> February 2022. During this time any dealing requests received by the Fund will be rejected.

While the Fund is suspended, you will be unable to buy, switch or redeem shares but you will continue to receive statements and updates.

At this stage, we are unable to say how long the Fund will be suspended for, but the decision will be reviewed on an ongoing basis.

In the meantime, we continue to work as hard as we can on behalf of investors to manage the Fund in accordance with its investment objectives and ensuring that the suspension can be lifted as soon as possible. We will take the decision to lift this suspension as soon as we consider it is in the best interests of existing shareholders to do so and will post regular updates to our website at [www.blackrock.com/hk](http://www.blackrock.com/hk)<sup>1</sup>.

Please be reassured that the suspension of the Fund has no impact on any other investments you may have in the BGF range.

The directors of BGF accept responsibility for the contents of this letter. To the best of the knowledge and belief of the directors of BGF (who have taken all reasonable care to ensure that this is the case) the information contained in this letter is in accordance with the facts and does not omit anything likely to affect the impact of such information.
