Inspection of Gold Bullion

The iShares Physical Metals PLC engaged Bureau Veritas Commodities UK Ltd. to conduct two inspections per year of the gold bullion stock held on behalf of the iShares Physical Gold Eur Hedged ETC at the vault of JPMorgan Chase Bank N.A., London Branch (the "Custodian"). The next regular inspection will be chosen by Bureau Veritas Commodities UK Ltd. during the calendar year 2024.

It is with pleasure that we submit below our reports to iShares Physical Metals PLC covering our count for record date as of 30th April 2024. In accordance with the agreed procedures, we hereby report the following:

Name of Account: iShares Physical Metals PLC for iShares Physical Gold Eur Hedged ETC

Material: London Good Delivery Gold Bars

Results: As at close of business 30th April 2024, this account held title to 37 gold bars with a total of 14,568.343 fine troy ounces, all London Good Delivery Gold Bars, said to be of purity of 99.50% minimum, up to and including 99.99%.

Description of Activity: Over the course of the inspection, we performed a full count of 37 bars of gold, based upon the Custodian's gold inventory as of 30th April 2024, including but not limited to the following:

- The gold inventory records of Administrator, State Street Bank and Trust Company, were reconciled to the records of the Custodian.
- Each individual bar in the gold count was agreed to the records of the Custodian as being held in the name of the above-mentioned account.
- Each bar was physically verified as correct through serial numbers, refiner brands and purities versus inventory reports and receipts supplied by the Custodian as at 30th April 2024.
- Five of the gold bars were selected at random and check weighed against the records of the Custodian.

Summary of Results:

All 37 bars were found to be in the vault, consistent with the stated records of iShares Physical Metals PLC. Reconciliation was performed on the physical movement of bars which occurred during the inspection period between 1st May and 3rd May 2024. The Custodian's records were found to have been correctly recorded.

Non-conformities: There were no administrative non-conformities identified in respect of the gold bars during the audit.

There were no non-conformities identified in respect of the gold bars as at 30th April 2024.
