2. Change in distribution policy of the iShares MSCI Asia ex Japan Climate Action ETF

As disclosed in the prospectus of the iShares MSCI Asia ex Japan Climate Action ETF (“**MSCI Asia Ex Japan ETF**”), the current distribution policy of the MSCI Asia Ex Japan ETF is that the Manager intends to make distributions of the Distributable Amount of the MSCI Asia Ex Japan ETF to its Unitholders annually, at the Manager’s discretion (usually in November/December each year) (if any).

With effect from 1 November 2024 (the “**Effective Date**”), the distribution policy of the MSCI Asia Ex Japan ETF will be changed such that the Manager does not intend to make any distribution of the income of the MSCI Asia Ex Japan ETF.
