FUND OVERVIEW

- The Fund is a sub-fund of BlackRock Authorised Contractual Scheme I taking the form of a Co-ownership Scheme. The Fund may be treated as tax transparent for the purpose of income and/or capital gains by relevant taxing jurisdictions. - The Fund aims to provide a return on your investment (generated through an increase to the value of the assets held by the Fund and/or income received from those assets) by tracking closely the performance of the MSCI World Small Cap ESG Screened Index, the Fund's benchmark index ("Benchmark Index").
