#### FUND OVERVIEW

- The Fund seeks to maximise total return.
- The Fund invests at least 80% of its total assets in the equity securities of companies globally that directly contribute to the transitioning materials theme. The transitioning materials theme covers the need for materials to build lower carbon technologies and efforts to reduce the emissions intensity of the materials sector.
- The Fund will aim to invest in line with the principles of the transition theme as determined by the Investment Adviser (IA) In normal market conditions the Fund will invest in a portfolio of equity securities of companies with large, medium and small market capitalisation, across all industry sectors, that contribute to the advancement of the transition theme across three categories as described in the prospectus: Emission Reducers, Enablers and Green Leaders. The companies are rated by the IA based on their ability to manage the risks and opportunities associated with the transition theme and on their environmental, social and governance (ESG) risk and opportunity credentials. The Fund's total assets will be invested in accordance with its ESG Policy as disclosed in the prospectus.

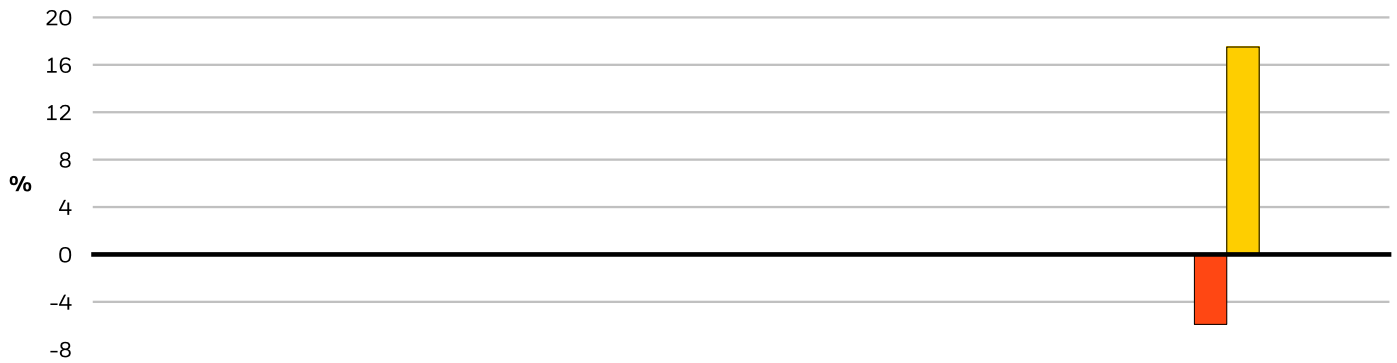

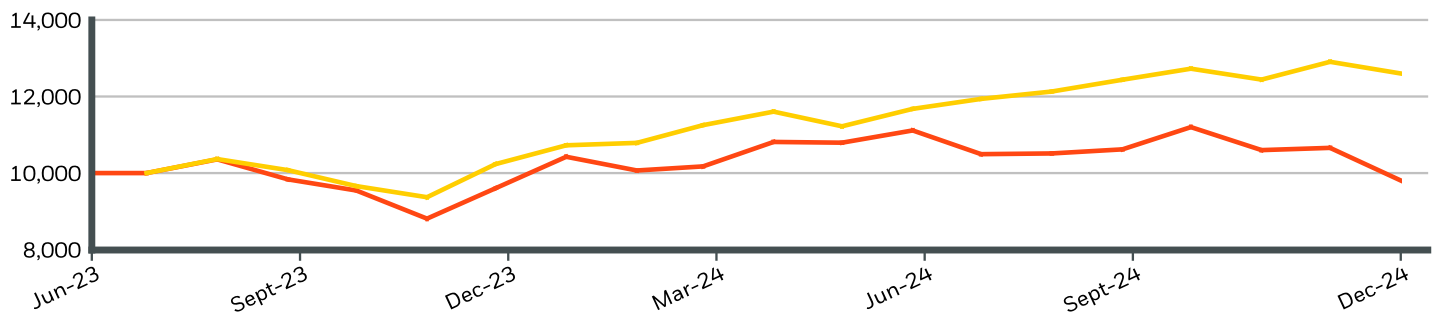

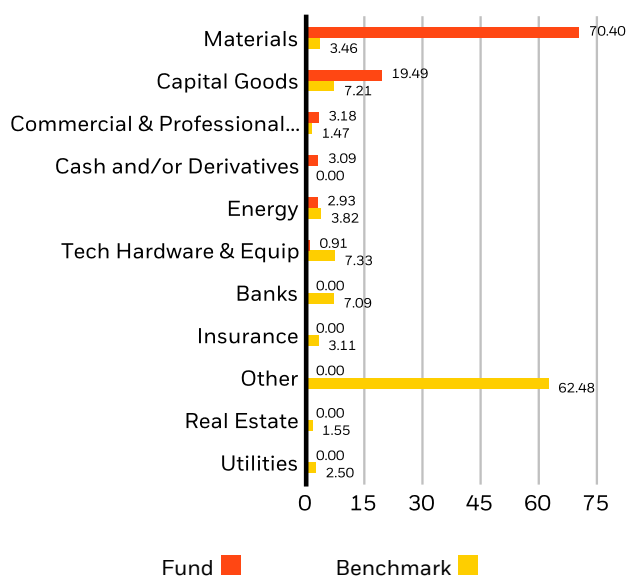

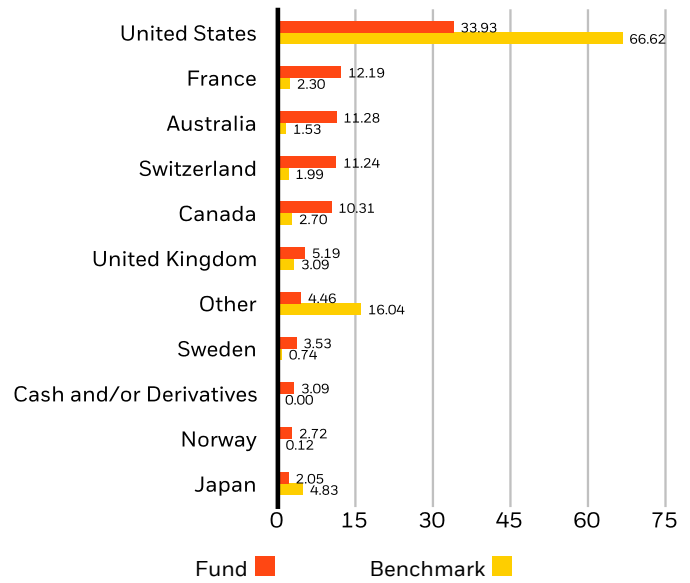

**SECTOR BREAKDOWN (%)**



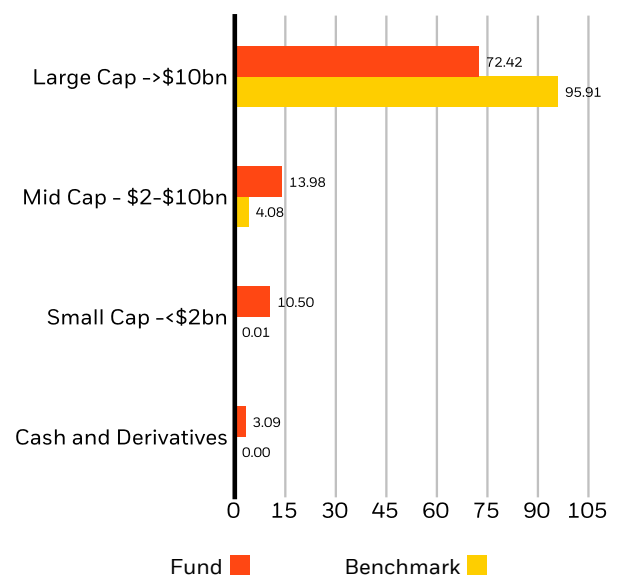
