FUND OVERVIEW

- The Fund aims to provide a return on your investment, in a sustainable way, through a combination of capital growth and income on the Fund's assets.
- The Fund invests globally at least 70% of its total assets in the equity securities (i.e. shares) of companies domiciled in, or whose main business is in, global emerging markets.
- The Investment Adviser (IA) engages with companies to support improvement in their environmental, social and governance (ESG) credentials and the Fund will invest in companies with sustainable business models which have a strong consideration for ESG risks and opportunities as described in the prospectus. The investment decisions are based on the IA's fundamental research focusing on bottom up (i.e. company-specific) analysis, inclusive of financial and non-financial metrics. The Fund will take into account ESG criteria when selecting investments as disclosed in the prospectus. 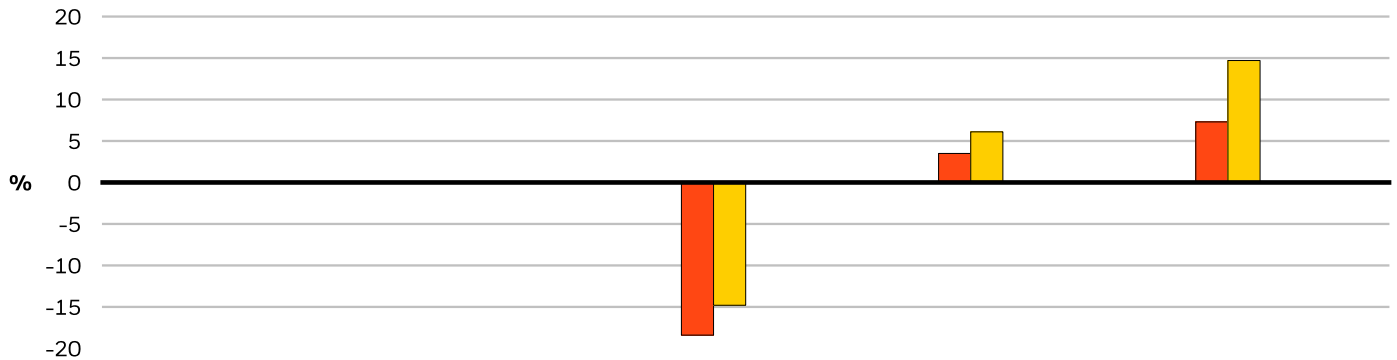

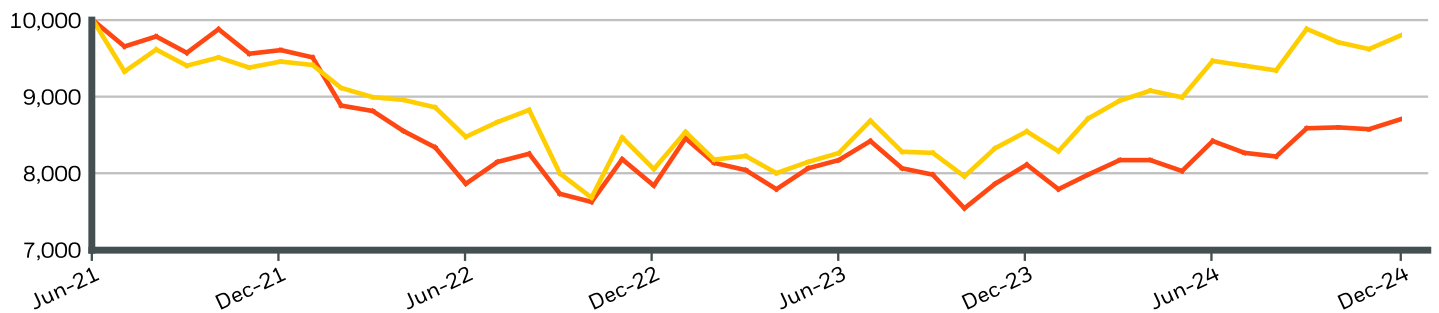

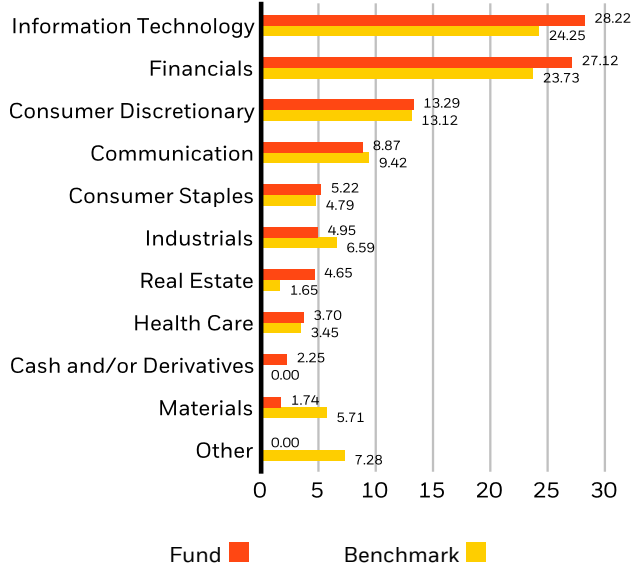

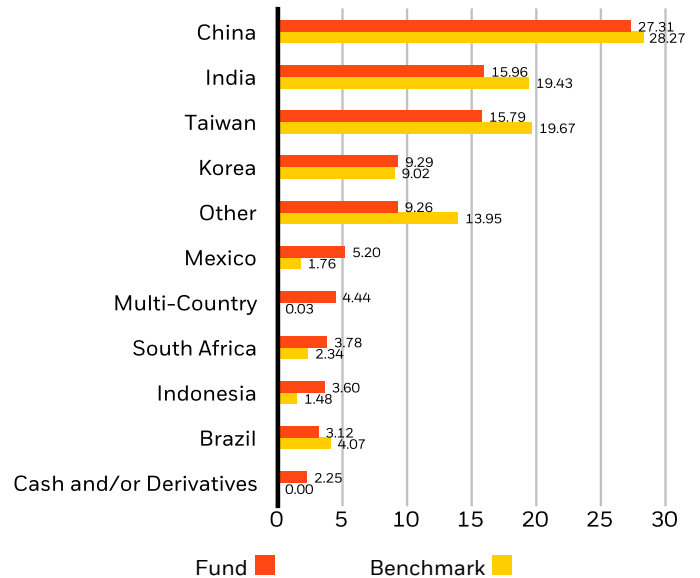

SECTOR BREAKDOWN (%)



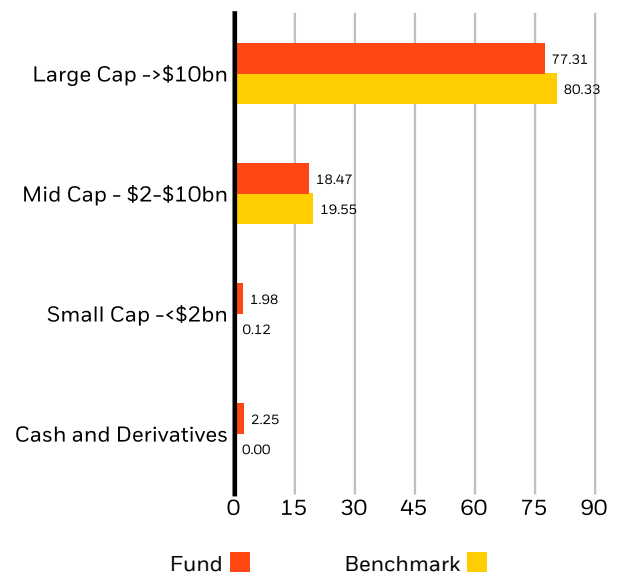
