FUND OVERVIEW

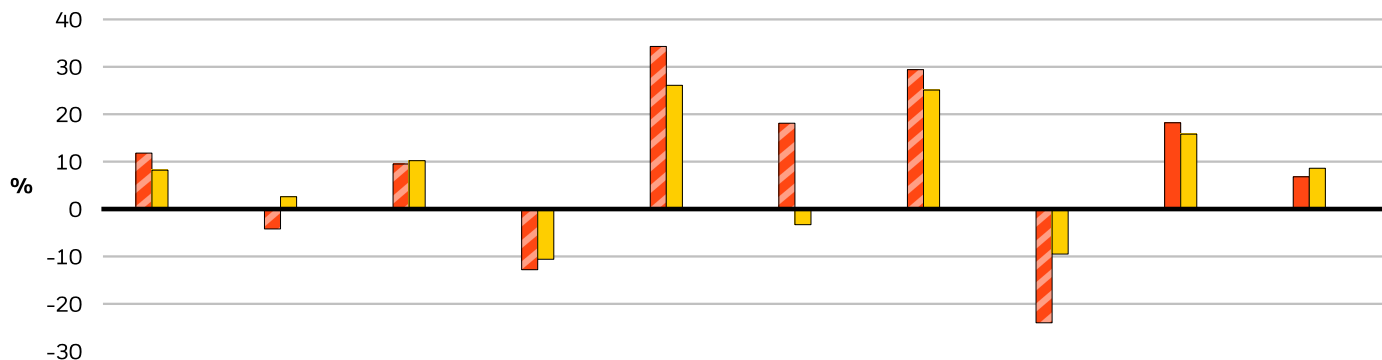

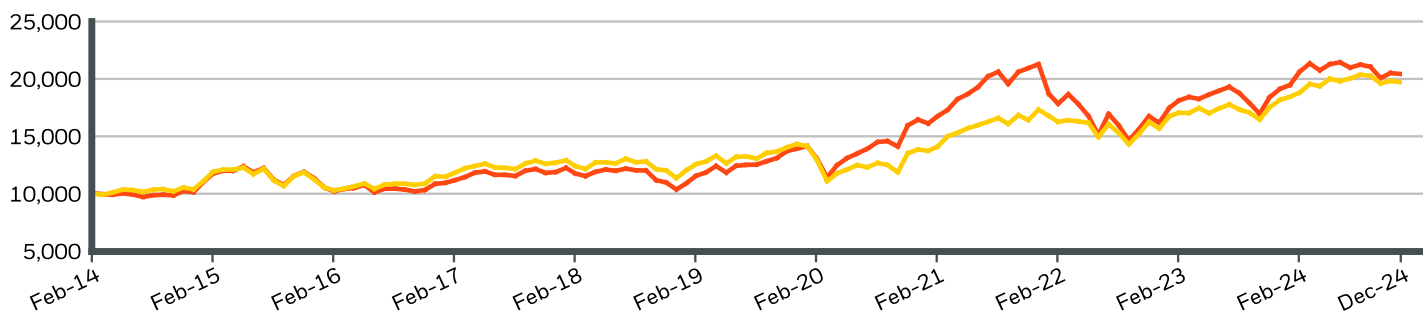

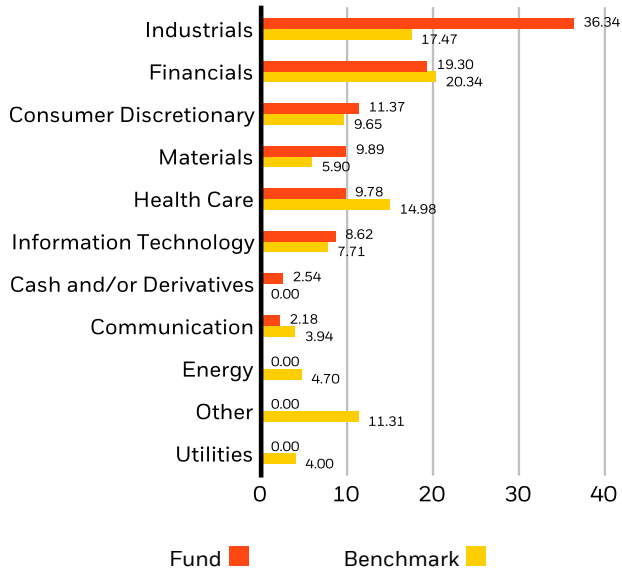

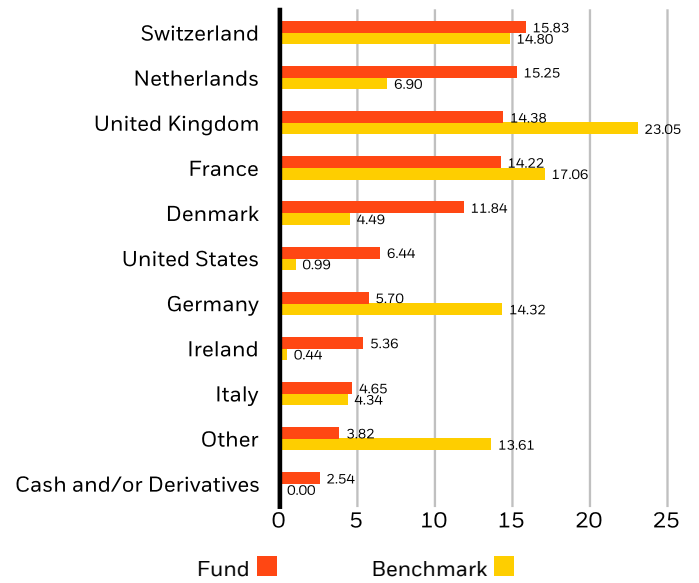

SECTOR BREAKDOWN (%)



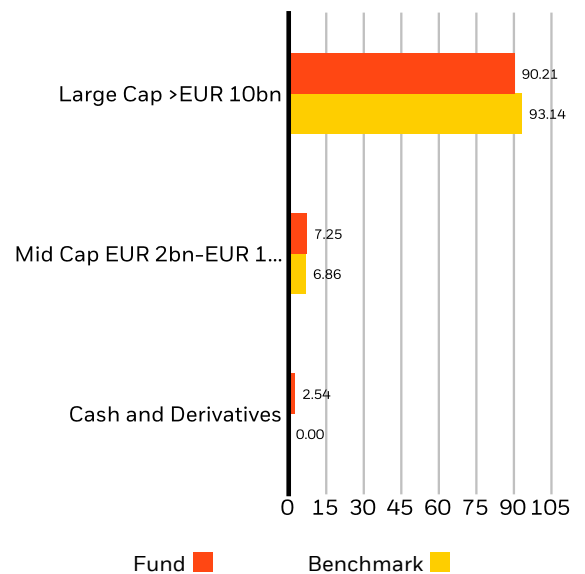

GLOSSARY
