FUND OVERVIEW

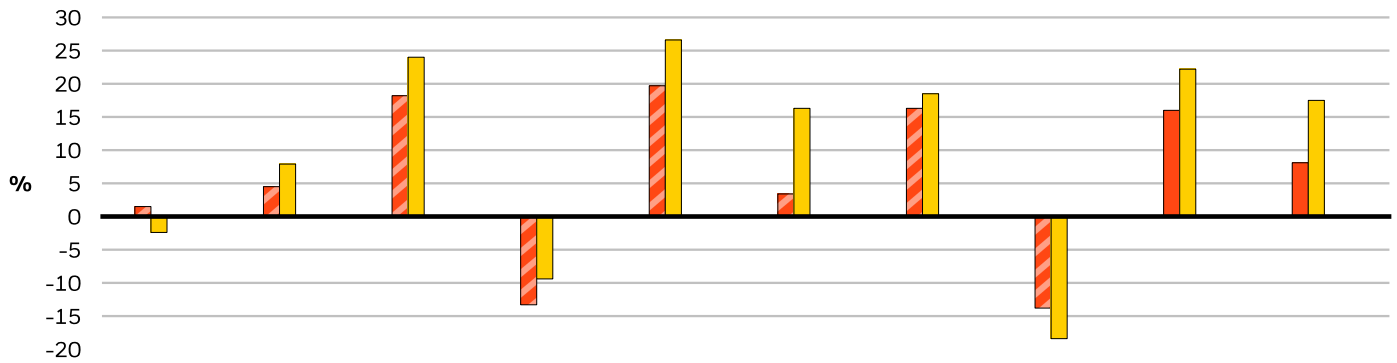

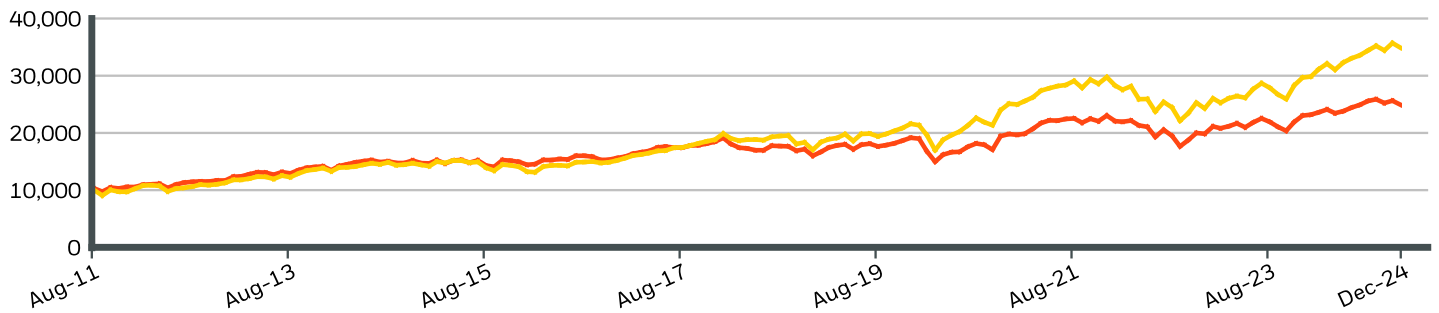

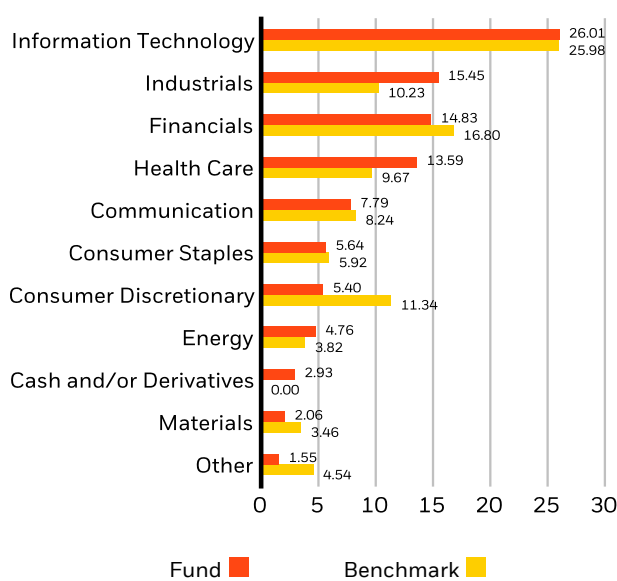

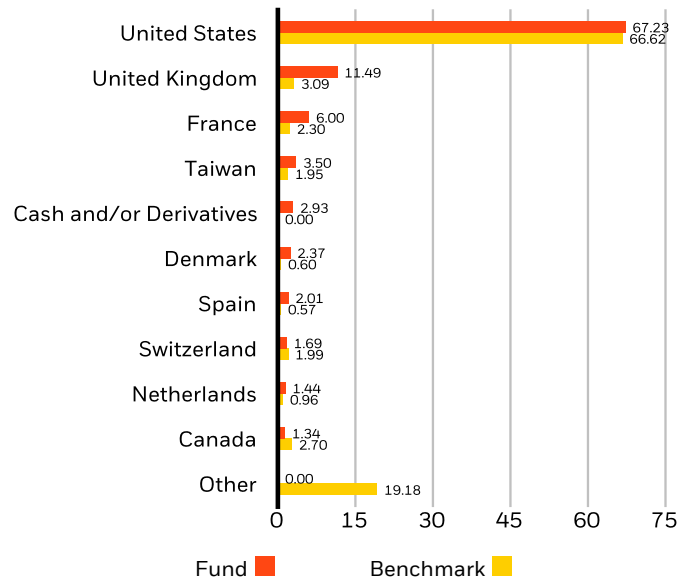

SECTOR BREAKDOWN (%)



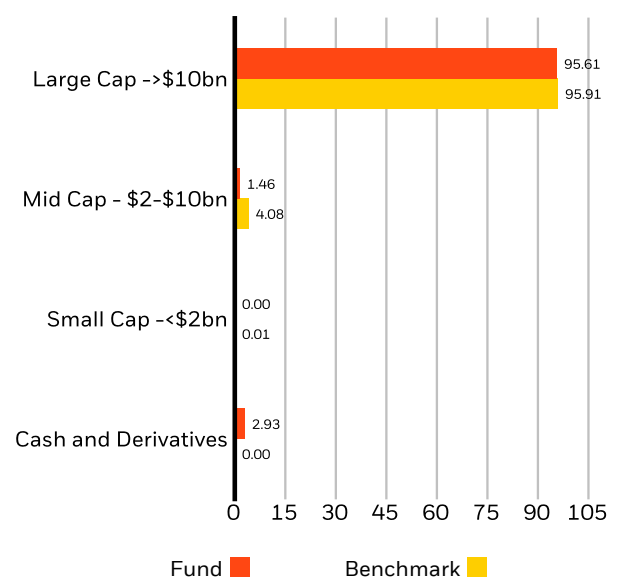
