#### FUND OVERVIEW

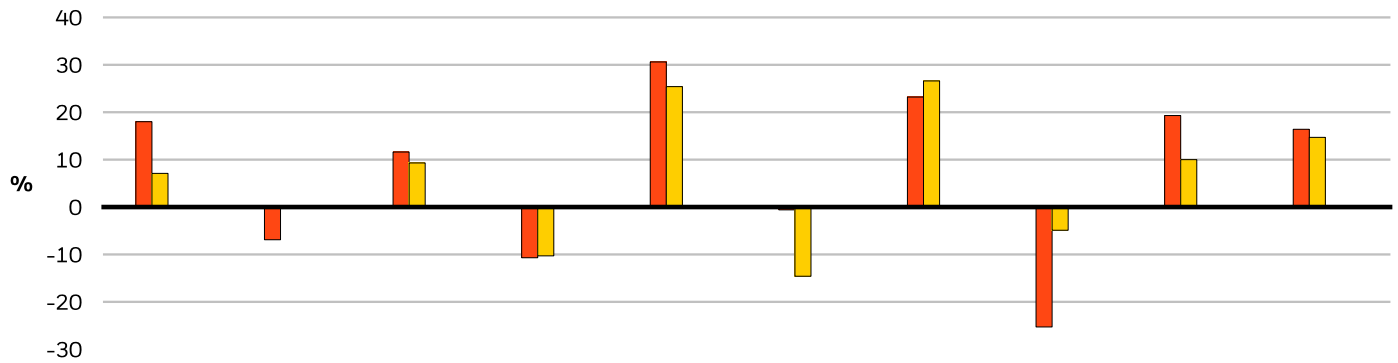

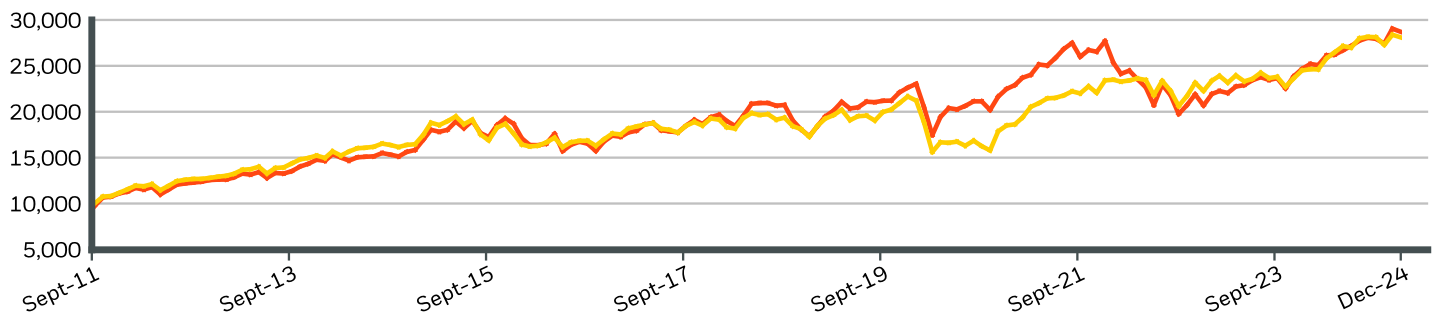

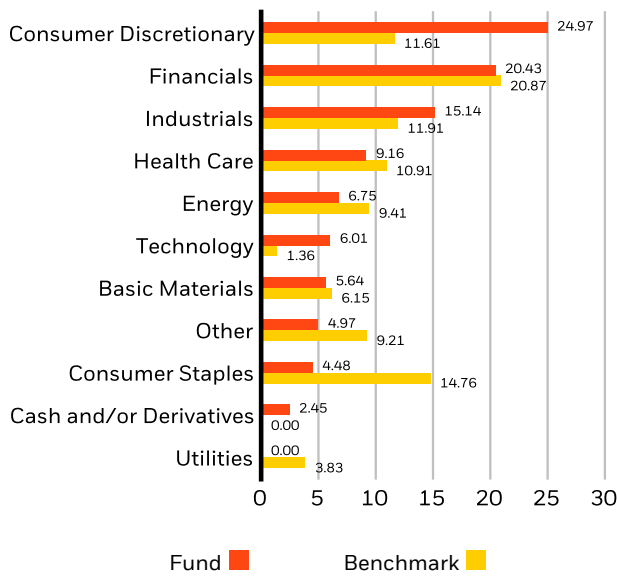

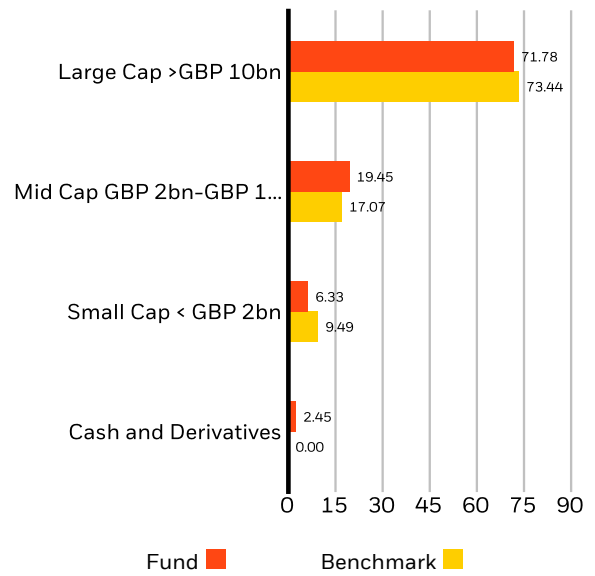
