The Fund may also invest in equity securities of companies the main business of which is precious metal or mineral mining and base metal or mineral mining.

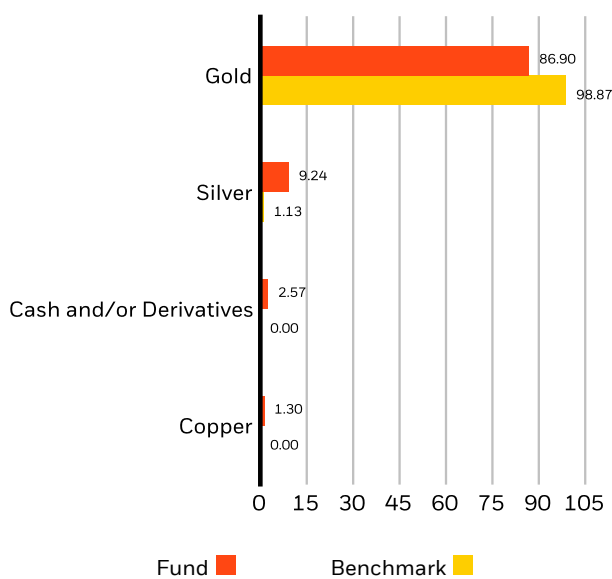

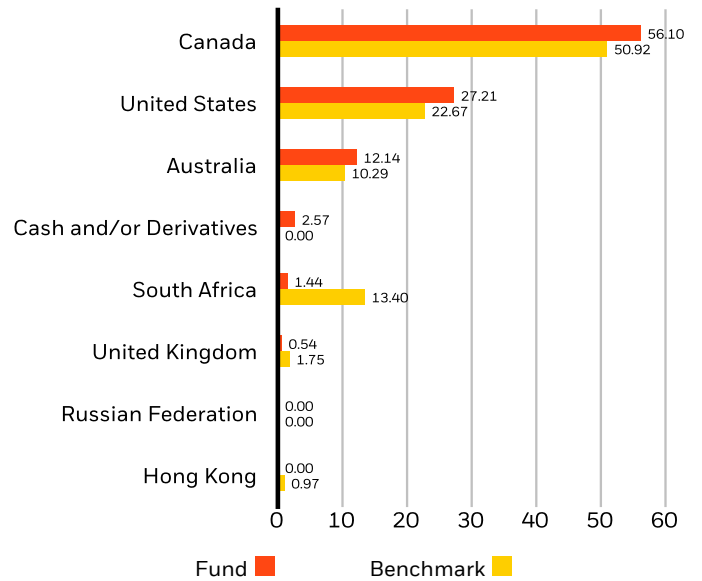

#### SECTOR BREAKDOWN (%)



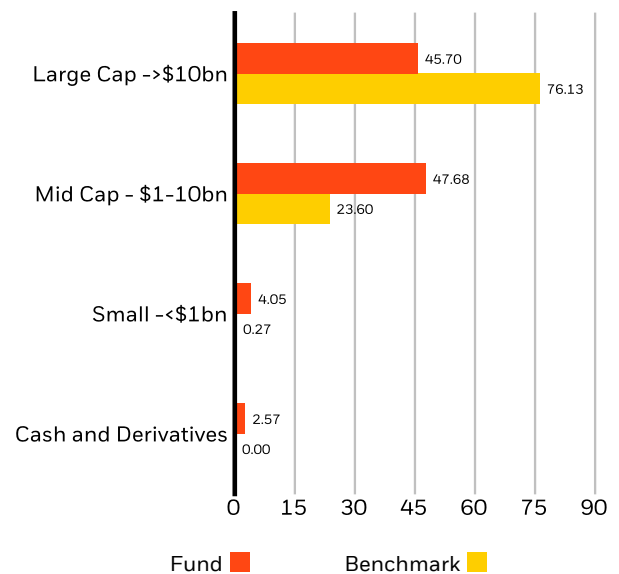
