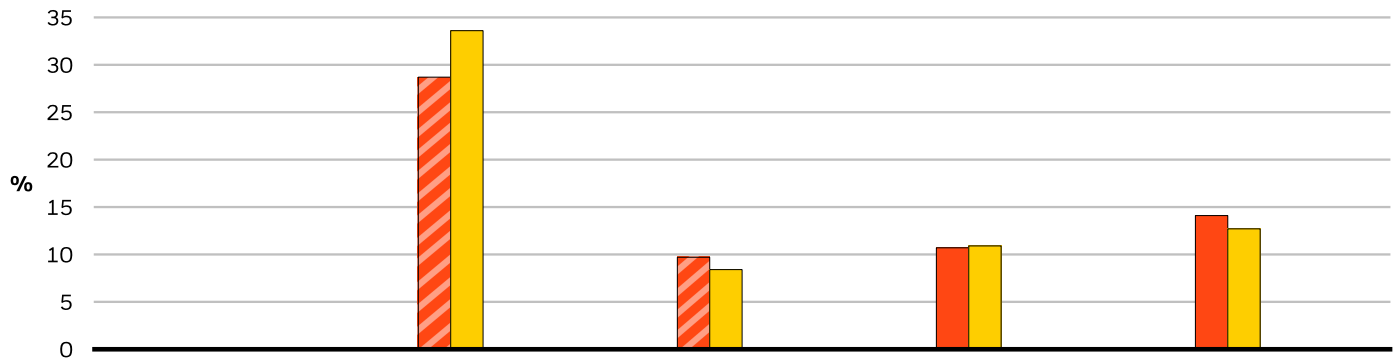

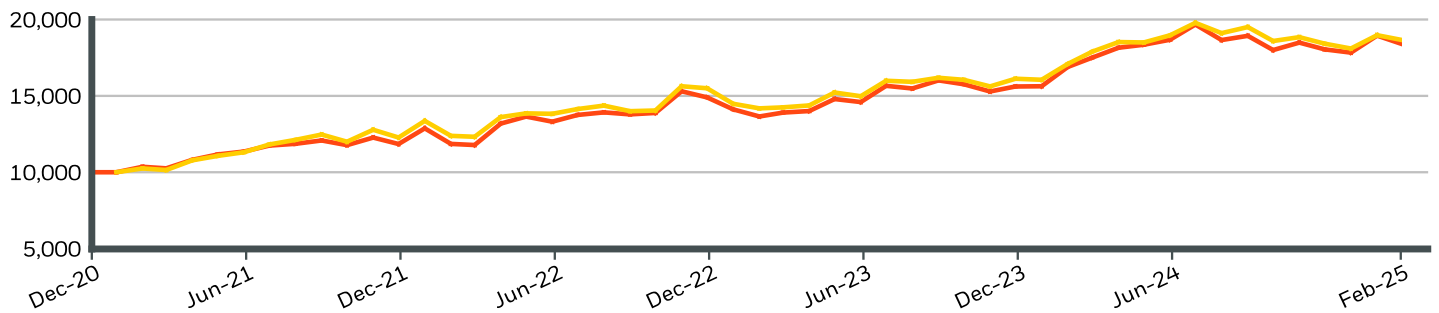

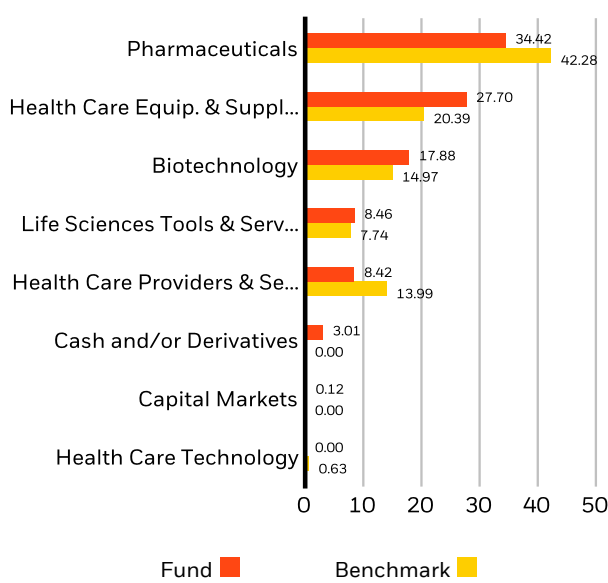

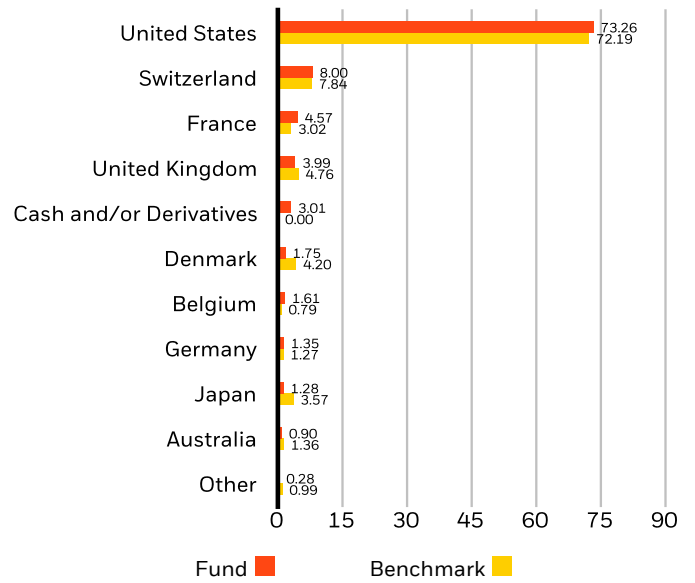

#### SECTOR BREAKDOWN (%)



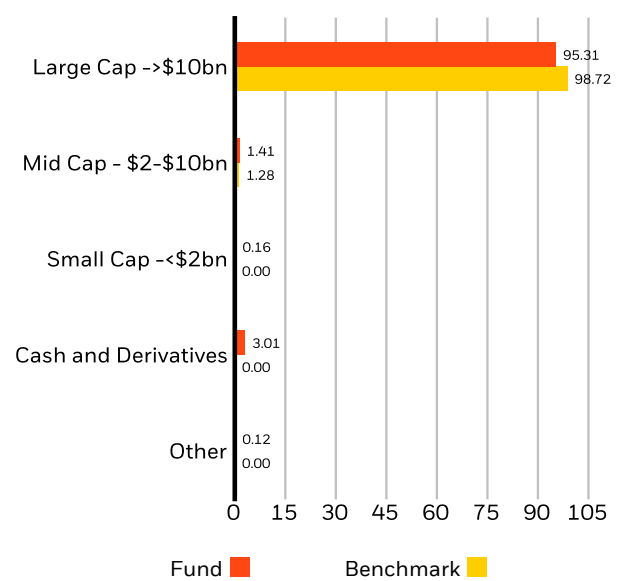
