### FUND OVERVIEW

- The Fund aims to maximise the return on your investment through a combination of capital growth and income on the Fund's assets in a manner consistent with the principles of environmental, social and governance (ESG) investing as disclosed in the Prospectus. - The Fund invests in the range of eligible assets for UCITS funds across the full capital structure of companies (i.e. debt and equity), and securities issued by governments and government agencies. Financial derivative instruments (FDIs) may be used to help achieve the Fund's investment objective. FDIs are investments the prices of which are based on one or more underlying assets.
- The Fund will invest at least 65% of its total assets in fixed income (FI) and FI related securities which may include investments with a relatively low credit rating or which are unrated. The Fund may invest up to 35% of its total assets in equity and equityrelated securities.

#### **KEY RISKS:**

- Changes to interest rates, credit risk and/or issuer defaults will have a significant impact on the performance of fixed income securities. 
