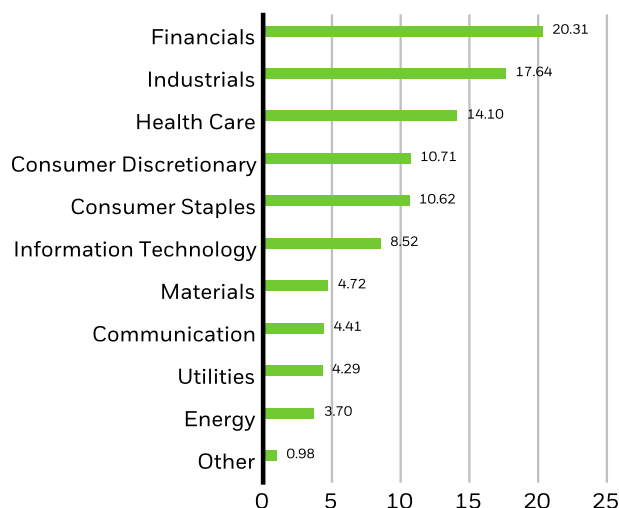

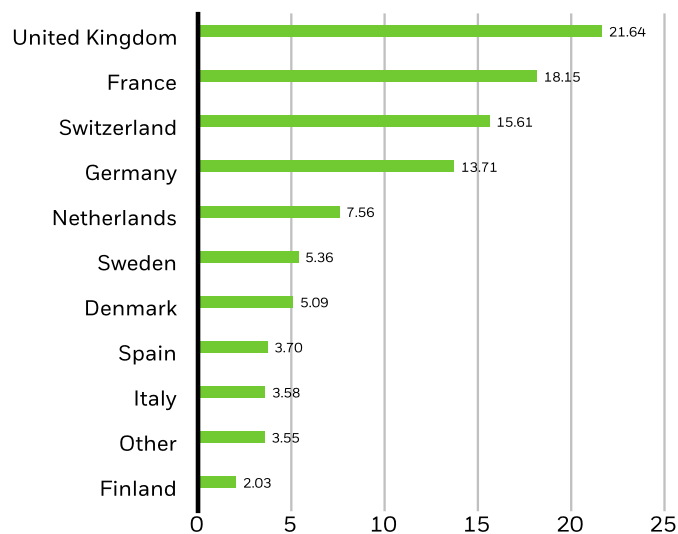
## SECTOR BREAKDOWN (%)
