## **FUND OVERVIEW**

- The Fund aims to provide a return on your investment through a combination of capital growth and income on the Fund's assets and invest in a manner consistent with the principles of environmental, social and governance (ESG) investing.
- The Fund is actively managed and the extent to which the Fund is invested in these
  asset classes may vary without limit depending on market conditions and other factors
  at the investment adviser's (IA) discretion. In selecting these, the IA may refer to a
  composite benchmark comprising the 25% MSCI World Index hedged to EUR, 25%
  MSCI World Index and 50% Bloomberg Global Aggregate Bond Index hedged to EUR
  ("Index") for risk management purposes.
- The Fund's investments may be issued by governments, government agencies, companies and supranationals. These may include securities with a relatively low credit rating or which are unrated.

#### **KEY RISKS:**







## **GLOSSARY**

**SFDR Classification: Article 8:** Products that promote environmental or social characteristics and promote good governance practices. **Article 9:** Products that have sustainable investments as an objective and follow good governance practices. **Other:** Products that do not meet the criteria to be classified as Article 8 or 9.

**Modified Duration:** A measure of price sensitivity of a bond to changes in interest rates. The Modified Duration of the fund is calculated as the average of the underlying bonds' modified duration values, adjusted to take account of their relative weight (size) within the fund.

**Price to Earnings:** A valuation ratio of a company's current share price compared to its per-share earnings in the current forecast year, calculated as current share price divided by current earnings per share.

**Average Market Cap:** The average market capitalization of a fund's equity portfolio gives you a measure of the size of the companies in which the fund invests. Market capitalization is calculated by multiplying the number of a company's shares outstanding by its price per share.

**Price to Book Ratio:** represents the ratio of the current closing price of the share to the latest quarter's book value per share.
