## FUND OVERVIEW

- The Fund aims to achieve a total return on your investment, through a combination of capital growth and income, which reflects the return of the J.P. Morgan ESG EMBI Global Diversified Index, the Fund's benchmark index (Index). The Fund invests predominantly in the fixed income (FI) securities (such as bonds) that make up the Index.
- The Index measures the performance of a sub-set of US Dollar denominated fixed and/or floating rate emerging market bonds issued by sovereign or quasi sovereign entities that are part of the J.P. Morgan EMBI Global Diversified Index ("Parent Index"). The Index includes only bonds that meet the index provider's socially responsible investing ("SRI") requirements and environmental, social and governance ("ESG") rating criteria and criteria for an emerging market country. For further details please refer to the prospectus.
- The Fund uses optimising techniques to achieve a similar return to its Index. These may include the strategic selection of certain securities that make up the Index and may also include the use of financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets). FDIs may be used for efficient portfolio management (i.e. to reduce risk within the Fund's portfolio, reduce investment costs and generate additional income).

## KEY RISKS:

- Changes to interest rates, credit risk and/or issuer defaults will have a significant impact on the performance of fixed income securities. - Emerging markets are generally more sensitive to economic and political conditions than developed markets. Such ESG screening may reduce the potential investment universe and this may adversely affect the value of the Fund's investments compared to a fund without such screening.

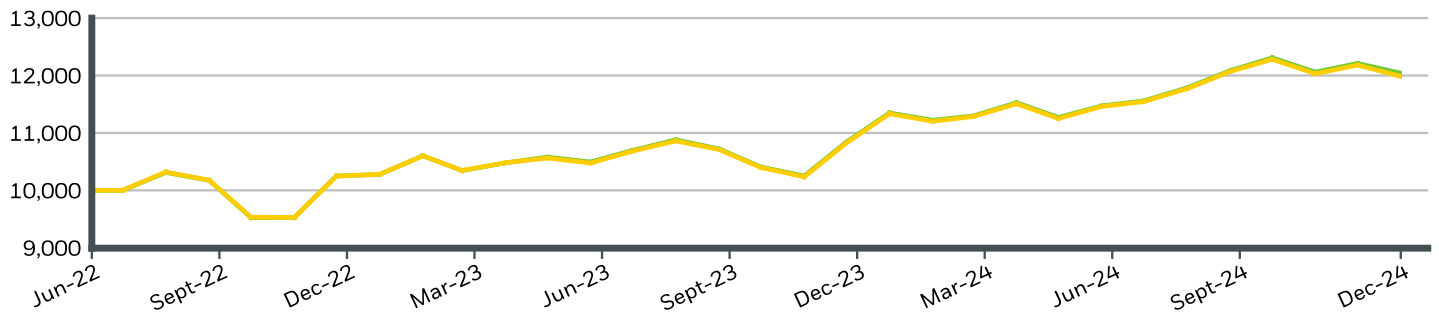

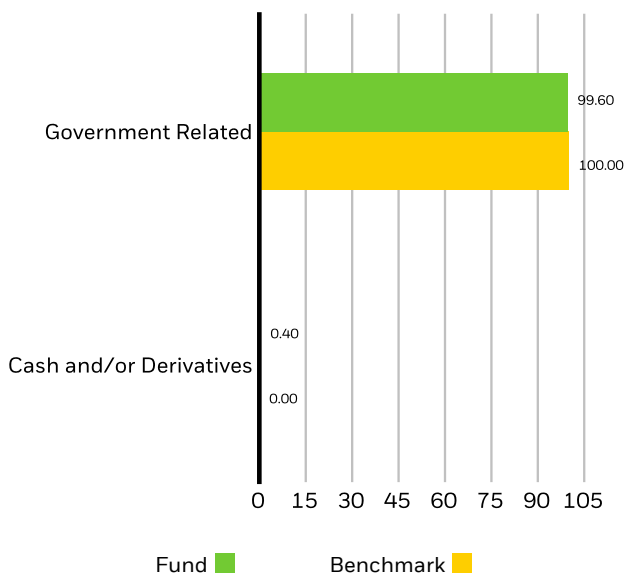

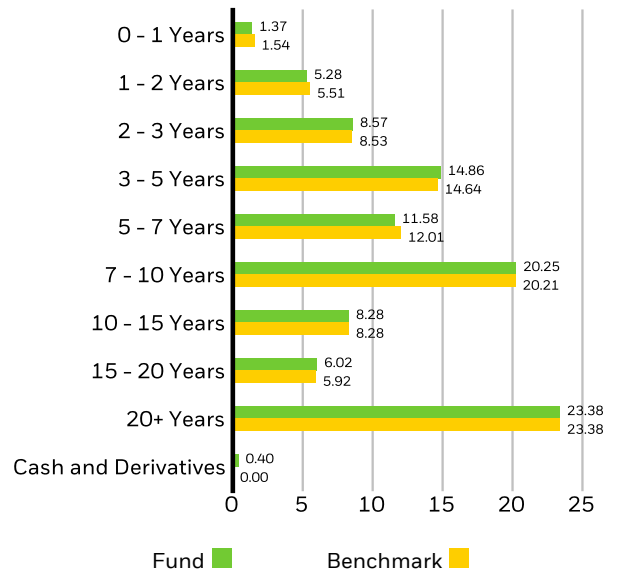

#### SECTOR BREAKDOWN (%)



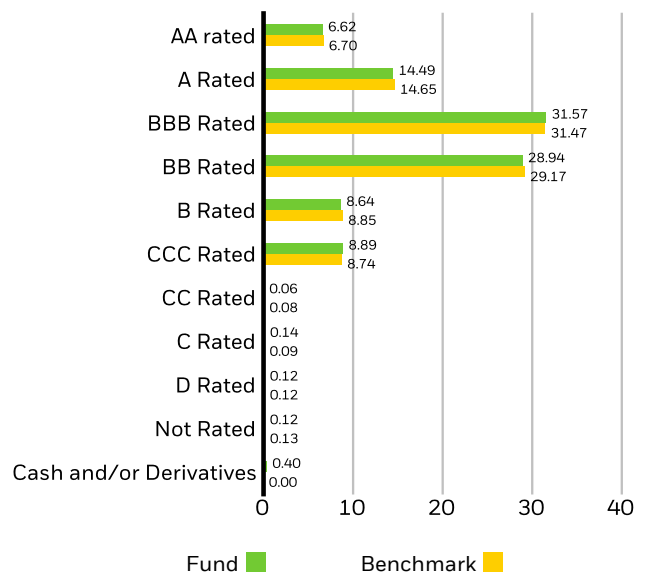

## GLOSSARY

**SFDR Classification: Article 8:** Products that promote environmental or social characteristics and promote good governance practices.

**Article 9:** Products that have sustainable investments as an objective and follow good governance practices. **Other:** Products that do not meet the criteria to be classified as Article 8 or 9.

**Yield to Maturity:** Yield to Maturity (YTM) is the discount rate that equates the present value of bond's cash flows with its market price (including accrued interest). The fund YTM is the weighted average of fund's individual bond holding YTM's based upon Net Asset Value ('NAV'). The measure does not include fees and expenses. For callable bonds, YTM is the Yield-to-Worst.

**Data Coverage %** is available input data for rating calculation at the Pillar level

**Effective Duration:** Effective duration is a measure of a fund's interest-rate sensitivity. Put simply, the longer a fund's duration, the more sensitive the fund is to shifts in interest rates. So a fund with a duration of 10 years is twice as volatile as a fund with a five-year duration.

**Analyst Driven %** is the analyst input into the overall rating assignment, including direct analyst coverage and inheritance of an analyst-rated pillar
