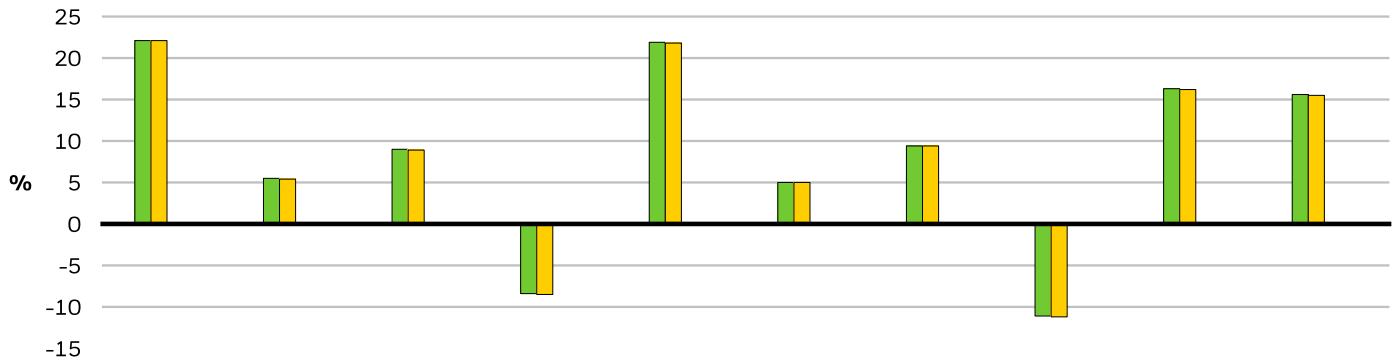

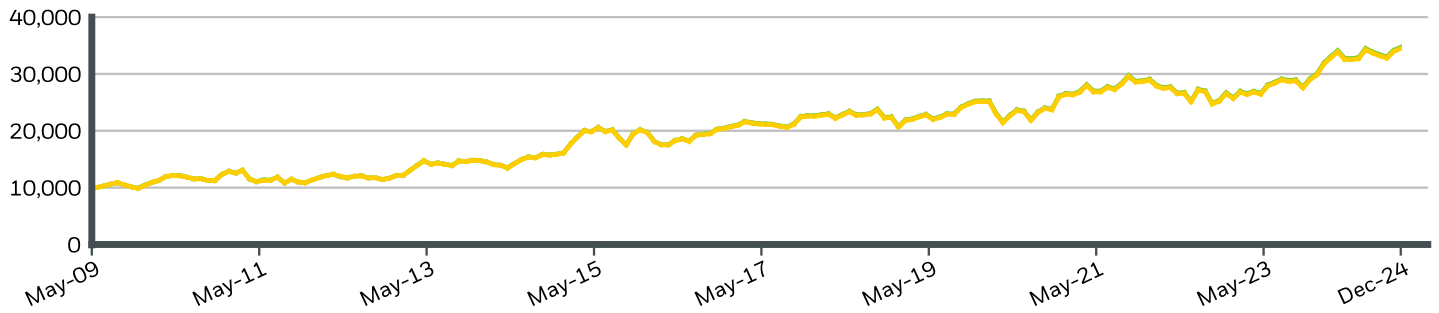

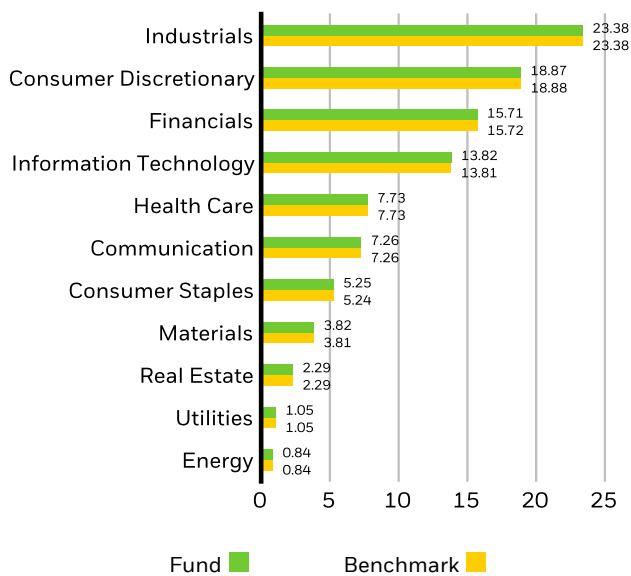

GLOSSARY
