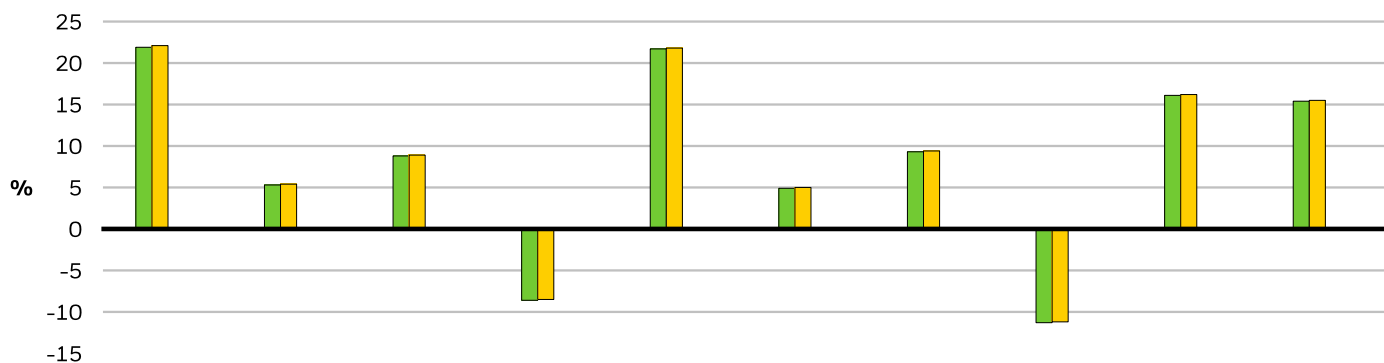

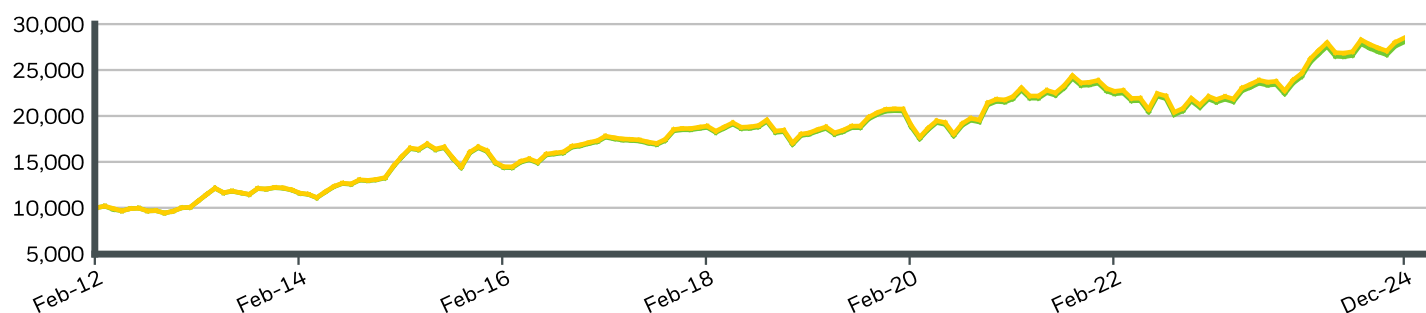

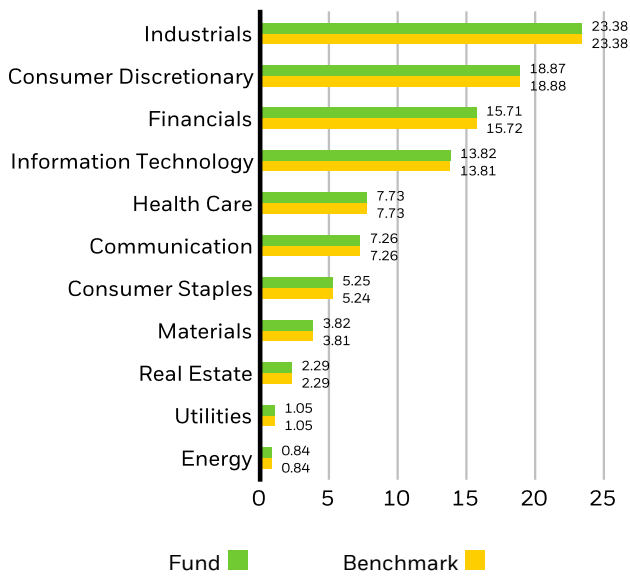

GLOSSARY
