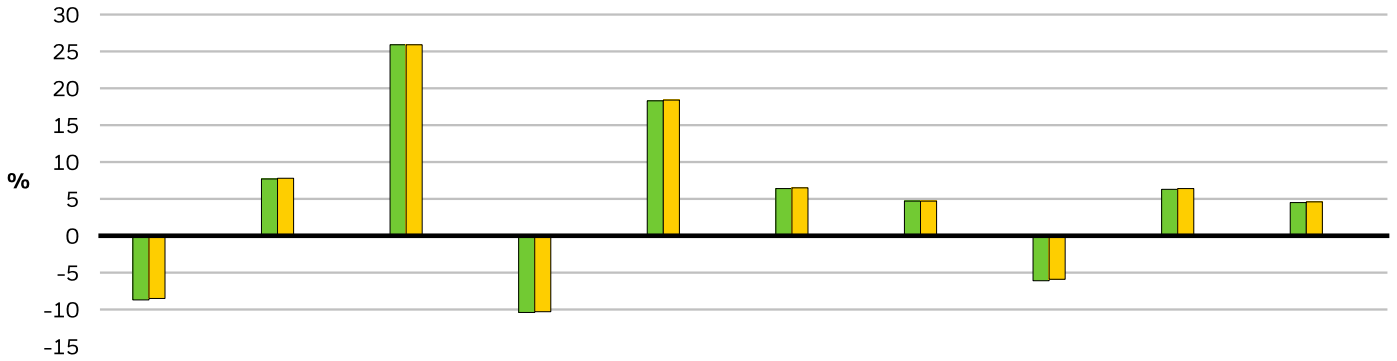

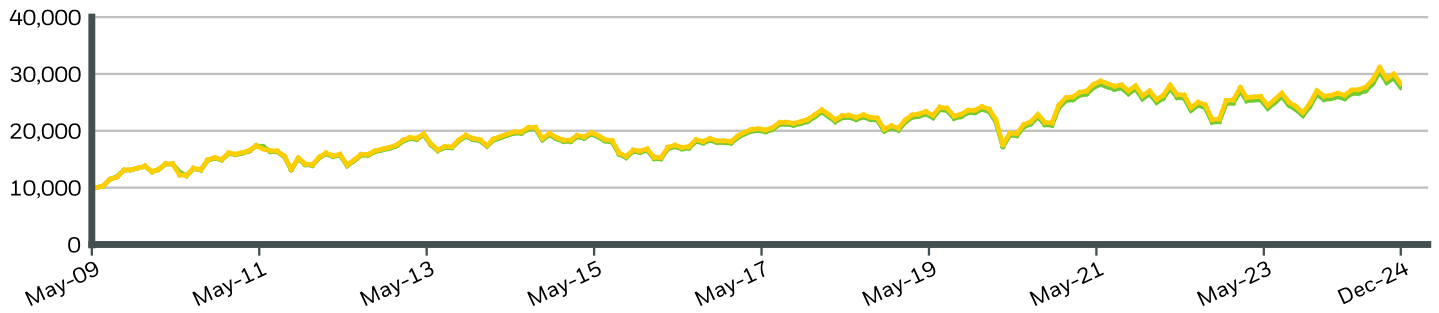

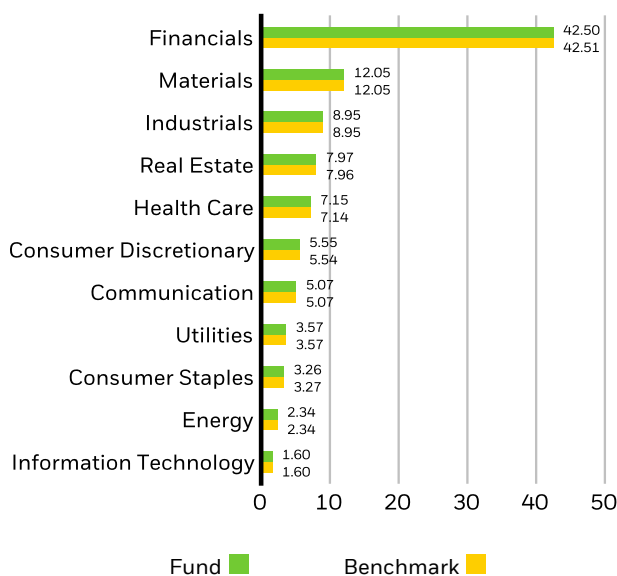

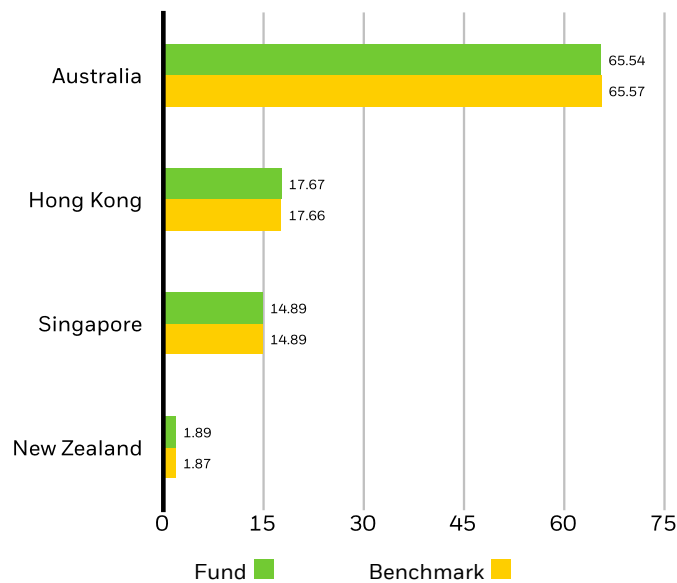

GLOSSARY
