

Objectives and Investment Policy

- ► The Fund is a sub-fund of BlackRock Authorised Contractual Scheme I taking the form of a Co-ownership Scheme. As a consequence of this, the Fund may be treated as tax transparent for the purpose of income and/or capital gains by relevant taxing jurisdictions. Each investor should take appropriate professional advice as to the tax treatment of their investment in the Fund. Investors in the Fund must be Eligible Investors as defined in the Fund's prospectus and must have completed all relevant documentation prior to the purchase of units in the Fund.
- ► The Fund aims to provide a return on your investment (generated through an increase to the value of the assets held by the Fund and/or income received from those assets) by tracking closely the performance of the MSCI World Low Carbon Target Reduced Fossil Fuel Select Index, the Fund's benchmark index (the "Benchmark Index").
- ▶ The Fund invests in equity securities (e.g. shares) of companies that make up the Benchmark Index.
- ► The Benchmark Index measures the performance of equity securities of large and mid-capitalisation companies across developed countries globally. The Benchmark Index is derived from the MSCI World Index (the "Parent Index") by identifying companies which remain after the index provider has excluded securities using predefined environmental, social and governance (ESG) screens and weighted securities using an optimisation process (as described in the Fund's prospectus), as determined by the index provider.
- ▶ The index provider excludes companies which are determined by the index provider to have negative environmental or social outcomes. Companies are excluded based on their involvement in the following business lines/activities thermal coal, mining thermal coal-based power generation, unconventional oil and gas extraction, oil sands extraction, conventional oil and gas extraction, oil and gas-based power generation, fossil fuel reserves (i.e. any companies that have coal and/or oil and natural gas reserves used for energy purposes and any company with "Very Severe ESG Controversies" as defined by the index provider (and which takes into account the OECD Guidelines for Multinational Enterprise and United Nations Global Compact principles).
- ▶ Once the climate change based exclusions are applied, the Benchmark Index is constructed using an optimisation process which aims to (i) minimise the carbon emissions intensity and potential emissions intensity of its constituents relative to the Parent Index; and (ii) create a portfolio with at least a 10% increase in the aggregate weight of issuers which set carbon emission reduction targets, whilst also applying a turnover budget (i.e. a limit of trading activity), a tracking error budget and other optimisation parameters applicable to the portfolio. Tracking error is a measure of the difference between a fund's actual returns and the returns of the Benchmark Index being tracked by such fund. Further detail on the optimisation process is outlined in the Fund's prospectus.
- ► The Fund is passively managed and the investment adviser has limited discretion to select the Fund's investments and in doing so will take into consideration the Benchmark Index. The Fund intends to replicate the Benchmark Index by holding the equity securities, which make up the Benchmark Index, in similar proportions to the Benchmark Index.
- ▶ The Fund may use derivatives (i.e. investments the prices of which are based on one or more underlying assets) to help achieve its investment objective or for efficient portfolio management purposes (EPM) (i.e. to reduce risk or costs within the Fund's portfolio, or generate additional income). The Fund may engage in short-term secured lending of its investments to certain eligible third parties to generate additional income and off-set costs.Recommendation: This Fund may not be appropriate for short-term investment.
- ▶ Recommendation: This Fund may not be appropriate for short-term investment.
- ▶ Your units will be accumulating units (i.e. dividend income will be included in their value).
- ▶ Your units will be denominated in Sterling, the Fund's base currency.
- ▶ You can buy and sell your units daily. The minimum initial investment for this unit class is £10,000,000.

- Investment risk is concentrated in specific sectors, countries, currencies or companies. This means the Fund is more sensitive to any localised economic, market, political, sustainability-related or regulatory events.

- The value of equities and equity-related securities can be affected by daily stock market movements. Other influential factors include political, economic news, company earnings and significant corporate events.
- The benchmark index only excludes companies engaging in certain activities inconsistent with ESG criteria if such activities exceed the thresholds determined by the index provider. Such ESG screening may reduce the potential investment universe and this may adversely affect the value of the Fund's investments compared to a fund without such screening.
- Particular risks not adequately captured by the risk indicator include:
 - Counterparty Risk: The insolvency of any institutions providing services such as safekeeping of assets or acting as counterparty to derivatives or other instruments, may expose the Fund to financial loss.
 - Tax treatment of Fund: The tax treatment of this fund structure is so far untested which could lead to adverse tax consequences for the investor.
 Changes to the tax status of the Fund could lead to taxation being due.

Charges

The charges are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The entry and exit charges shown are maximum figures. In some cases you might pay less. Please refer to your financial advisor or the distributor for the actual entry and exit charges.

*Subject to a charge of up to 2% paid into the Fund where the Manager suspects excessive trading by an investor.

The ongoing charges figure is based on expenses for the twelve month period ending 31 December 2024. This figure may vary from year to year. It excludes portfolio trade-related costs, except costs paid to the custodian and any entry/exit charge paid to an underlying collective investment scheme (if any).

** (i) To the extent the Fund undertakes securities lending to reduce costs, the Fund will receive 62.5% of the associated revenue generated and the remaining 37.5% will be received by BlackRock as the securities lending agent. As securities lending revenue sharing does not increase the costs of running the Fund, this has been excluded from the ongoing charges. (ii) Holders in this unit class may be subject to additional periodic charges outside of the Fund by way of separate agreement with BlackRock.


Past Performance
