# Objectives and Investment Policy

- ▶ The Fund aims to achieve a total return on your investment through a combination of capital growth and income on the Fund's assets.
- ► The Fund seeks to achieve its objective by investing at least 80% of its assets in fixed income (FI) securities (such as bonds) issued by high yield (i.e. non-investment grade (IG) or unrated) corporate issuers and instruments related to such FI securities, including financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets), and issued in developed markets. The Fund may invest up to 20% of its assets in emerging markets.
- ► The IM considers certain environmental, social and governance (ESG) characteristics when selecting securities to be held directly by the Fund. For further details please see the BlackRock website at https://www.blackrock.com/baselinescreens. The IM will create a portfolio with a higher ESG outcome versus the ICE BofA Merrill Lynch Developed Market High Yield Constrained 100% USD Hedged Index (the Index). The weighted average ESG rating of the Fund will be higher than the Index's ESG rating. The IM intends the Fund to have a lower carbon emissions intensity score than the Index.
- ▶ The Fund may invest in FI securities issued by governments, government agencies and supranationals and/or FI securities which are IG (i.e. meet a specified level of credit worthiness), instruments related to such FI securities, money market instruments (debt securities with short-term maturities), deposits and cash.
- ▶ The Investment Manager (IM) uses a 'credit screening' strategy and quantitative models to respectively minimise exposure to the FI securities seen to be most at risk of a sharp deterioration in price and rank securities. Please refer to the prospectus for further details.
- ► The IM may use FDI's to help achieve the Fund's investment objective and may thereby generate market leverage (i.e. market exposure in excess of the value of its assets).
- ▶ The Fund is actively managed and the IM has discretion to select the Fund's investments. The IM refers to the Index when constructing the Fund's portfolio, and also for risk management purposes to ensure that the active risk (i.e. degree of deviation from the Index) taken by the Fund remains appropriate given the Fund's investment objective and policy. The Fund is designed to provide investors with a selected exposure to the Index which may generate a modest positive or negative tracking difference. The IM is not bound by the components or weighting of the Index and may use its discretion to invest in securities not included in the Index. The credit rating requirements of the investment objective and policy limit the deviation of the portfolio holdings from the Index. The Index should be used by investors to compare the performance of the Fund.
- ▶ Recommendation: This Fund may not be appropriate for short-term investment.
- ▶ Your shares will be accumulating shares (i.e. dividend income will be included in their value).
- ▶ Your shares will be denominated in US Dollar, the Fund's base currency.
- ▶ You can buy and sell your shares daily. The minimum initial investment for this share class is US\$5,000 or other currency equivalent.

- ► The Fund is rated four due to the nature of its investments which include the risks listed below. These factors may impact the value of the Fund's investments or expose the Fund to losses.
- Changes to interest rates, credit risk and/or issuer defaults will have a significant impact on the performance of fixed income securities. Noninvestment grade fixed income securities can be more sensitive to changes in these risks than higher rated fixed income securities. Potential or actual credit rating downgrades may increase the level of risk.
- The Fund seeks to exclude companies engaging in certain activities inconsistent with ESG criteria. Such ESG screening may reduce the potential investment universe and this may adversely affect the value of the Fund's investments compared to a fund without such screening.
- ▶ Particular risks not adequately captured by the risk indicator include:
  - Counterparty Risk: The insolvency of any institutions providing services such as safekeeping of assets or acting as counterparty to derivatives or other instruments, may expose the Fund to financial loss.
  - Credit Risk: The issuer of a financial asset held within the Fund may not pay income or repay capital to the Fund when due.
  - Liquidity Risk: Lower liquidity means there are insufficient buyers or sellers to allow the Fund to sell or buy investments readily.

## Charges

The charges are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The entry and exit charges shown are maximum figures. In some cases you might pay less. Please refer to your financial advisor or the distributor for any charges which they themselves may apply.

\*Subject to a charge of up to 2% paid into the Fund where the Manager suspects excessive trading by an investor.

The ongoing charges figure is based on the fixed annualised fees charged to the Fund as set out in the Fund's prospectus. This figure excludes portfolio trade-related costs, except costs paid to the custodian and any entry/exit charge paid to an underlying collective investment scheme (if any).

\*\* To the extent the Fund undertakes securities lending to reduce costs, the Fund will receive 62.5% of the associated revenue generated and the remaining 37.5% will be received by BlackRock as the securities lending agent. As securities lending revenue sharing does not increase the costs of running the Fund, this has been excluded from the ongoing charges.


# Past Performance
