#### **Objectives and Investment Policy**

- The Fund aims to provide a return on your investment (generated through an increase in the value of the assets held by the Fund and/or income received from those assets) which exceeds 3 month Sterling Overnight Index Average Rate (SONIA) compounded in arrears by 3.5 % per annum (gross of fees) over the medium to long term (3 to 5 consecutive years). Compounding in arrears is a methodology that compounds daily values of the overnight rate throughout the relevant term period (i.e.3 Months).
- The Fund will invest on a global basis in any or all of the following asset classes: equity securities (e.g. shares), fixed income securities (e.g. bonds), permitted moneymarket instruments (e.g. debt instruments with short-term maturities), permitted deposits, cash, other funds and derivatives (i.e. investments the prices of which are based on one or more underlying assets).
- The above-mentioned asset classes and the extent to which the Fund is invested in these may vary without limit depending on market conditions and other factors at the investment adviser's (IA) discretion.
- The fixed income securities and money market instruments may be issued by governments, government agencies, companies and supranationals (e.g. The International Bank for Reconstruction and Development). The Fund may invest in a full range of fixed income securities and money market instruments which may include investments with a relatively low credit rating or which are unrated.
- ▶ The Fund may invest up to 100% of its net asset value in other funds to help achieve its investment objective.
- The IA may use derivatives to help achieve the Fund's investment objective. Derivatives may be used to gain indirect exposure to commodities (such as precious metals and agricultural produce) and property.
- ▶ The Fund may, via the use of derivatives, generate varying amounts of market leverage (i.e. where the Fund gains market exposure in excess of the value of its assets).
- At any one time, a substantial amount of the Fund's assets may be held as cash to provide cover for the exposure created by the use of derivatives or to assist in achieving its investment objective.
- The Fund is actively managed and the IA has discretion to select the Fund's investments and is not constrained by any benchmark in this process. 3 month SONIA compounded in arrears (plus 3.5% per annum (gross of fees) should be used by unitholders to compare the performance of the Fund.
- The Fund also has a comparator benchmark of 30% MSCI All Country World Index with Developed Markets (100% Hedged to GBP) / 70% Bloomberg Global Aggregate Index (GBP Hedged) which can be used by unitholders as an alternative performance measure to assess performance in the Fund, which the IA considers better reflects the market risk embedded in the Fund.
- ▶ Recommendation: This Fund may not be appropriate for short-term investment.
- ► Your units will be accumulating units (i.e. dividend income will be included in their value).
- ► Your units will be denominated in Sterling, the Fund's base currency.
- ▶ You can buy and sell your units daily. The minimum initial investment for this unit class is £100,000.

- The Fund is rated four due to the nature of its investments which include the risks listed below. These factors may impact the value of the Fund's investments or expose the Fund to losses.
  - Changes to interest rates, credit risk and/or issuer defaults will have a significant impact on the performance of fixed income securities. Noninvestment grade fixed income securities can be more sensitive to changes in these risks than higher rated fixed income securities. Potential or actual credit rating downgrades may increase the level of risk.
  - The value of equities and equity-related securities can be affected by daily stock market movements. Other influential factors include political, economic news, company earnings and significant corporate events.

- The Fund uses quantitative models in order to make investment decisions. As market dynamics shift over time, a quantitative model may become less efficient or may even present deficiencies under certain market conditions.
- Particular risks not adequately captured by the risk indicator include:
  - Counterparty Risk: The insolvency of any institutions providing services such as safekeeping of assets or acting as counterparty to derivatives or other instruments, may expose the Fund to financial loss.
  - Credit Risk: The issuer of a financial asset held within the Fund may not pay income or repay capital to the Fund when due. If a financial institution is unable to meet its financial obligations, its financial assets may be subject to a write down in value or converted (i.e. "bail-in") by relevant authorities to rescue the institution.
  - Liquidity Risk: Lower liquidity means there are insufficient buyers or sellers to allow the Fund to sell or buy investments readily.

#### Charges

The charges are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The entry and exit charges shown are maximum figures. In some cases you might pay less. Please refer to your financial advisor or the distributor for the actual entry and exit charges.



As securities lending revenue sharing does not increase the costs of running the Fund, this has been excluded from the ongoing charges.
