

**Purpose**

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**Product**

**BlackRock Pension Growth Fund** (the "Fund"), **Class X1 Acc GBP** (the "Unit Class"), ISIN: **GB00BFX16M89**, is manufactured by BlackRock Fund Managers Limited (the "Manager"). The Manager is authorised in the UK and regulated by the Financial Conduct Authority (the "FCA"). **What is this product?**

**Type:** The Fund is a sub-fund of BlackRock Authorised Contractual Scheme (2), an umbrella authorised contractual scheme, authorised by the Financial Conduct Authority as a non-UCITS retail scheme operated as a fund of alternative investment funds. The Fund is classified as an alternative investment fund for regulatory purposes.

**Term:** The Fund does not have a fixed term of existence or maturity period, but in certain circumstances the Manager and the Depositary must wind up the Scheme or terminate a Fund if directed to do so by the FCA in exercise of its powers under section 261X of FSMA, or if an extraordinary resolution to that effect is passed by the unitholders, provided the FCA has consented to the resolution, and in each case subject to compliance with the Fund's prospectus and applicable regulation.

**Objectives**

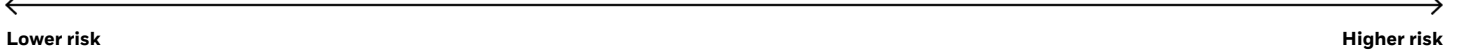
- The Fund's objective is to provide a return on your investment (generated through an increase in the value of the assets held by the Fund and/or income received from those assets) over the long-term (five or more consecutive years).
- The Fund intends to gain indirect exposure globally to equity securities (i.e. shares), fixed income (FI) securities (such as bonds) and alternative assets (i.e. assets that are not publicly traded or otherwise not readily transferable or realisable) by investing at least 70% of its total assets in other funds. The exposure to alternative assets will be achieved by the Fund investing in one or more long-term asset funds (LTAFs) that invest at least 50% of their assets in alternative assets such as private equity, private debt, private real estate and/or private infrastructure. Up to 25% of the Fund's assets may be invested in LTAFs (in aggregate).
- The Fund may also invest directly in equity securities, FI securities, money market instruments and cash. The Fund's exposure to equity securities (whether direct or indirect) will represent at least 50% of its total assets.
- The Fund's investment manager (IM) may use derivatives (i.e. investments the prices of which are based on one or more underlying assets) to help achieve the Fund's investment objective.
- The Fund may engage in short term secured lending of its investments to certain eligible third parties. This is used as a means of generating additional income and to off-set the costs of the Fund.
- The Fund is actively managed and the IM has discretion to select the Fund's investments.
- At least 80% of the Fund's total assets invested in other funds (excluding government bond or cash funds) will be invested in funds which apply environmental, social and governance (ESG) exclusionary screens at the time of investment based on pre-defined criteria (as set out in the Fund's prospectus). The IM will also consider whether and how a fund embeds other sustainability considerations, alongside other factors, when considering funds for investment but makes no commitment to invest in such funds.
- The Fund invests in funds, FI securities, equity securities, alternative assets and derivatives and so the value of your investment may be affected by the factors which impact the value of those assets.
- The price of FI securities may be affected by changing interest rates which in turn may affect the value of your investment. FI securities prices move inversely to interest rates. Therefore, the market value of FI securities may decrease as interest rates increase. The credit rating of an issuing entity will generally affect the yield that can be earned on FI securities; the better the credit rating the smaller the yield.
- The price of equity securities fluctuates daily and may be influenced by factors affecting the performance of the individual companies issuing the equities, as well as by daily stock market movements, and broader economic and political developments which in turn may affect the value of your investment.
- LTAFs invest in long term illiquid assets, and it may therefore take a significant period of time for an LTAF to make an investment. The assets of LTAFs may be subject to legal or other restrictions on transfer and no liquid market may exist (i.e. it may not be possible to sell the asset for an extended period of time or at all). The market prices, if any, for such assets tend to be volatile and may not be readily ascertainable, and LTAFs may not be able to sell them when they want to, or realise what they perceive to be their fair value upon sale.
- The price of underlying funds changes regularly depending on the performance of the assets held by them which in turn may affect the value of your investment.
- Recommendation: This Fund may not be appropriate for short-term Investment.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below).
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below under "How long should I hold it and can I take my money out early?"
- Your units will be denominated in Sterling, the Fund's base currency. Where the Fund invests in assets denominated in a currency other than Sterling, the IM may use derivatives including currency forwards (a type of derivative which locks in the price at which an entity can buy or sell a currency at a future date) in order to reduce the effect of fluctuations in the exchange rate between that other currency and Sterling.
- Your units will be accumulating units (i.e. dividend income will be included in their value).
- You can buy and sell your units daily. The minimum initial investment for this unit class is £50,000,000.

**Intended retail investor:** The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund.

**Insurance benefits:** The Fund does not offer any insurance benefits.

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
- We have classified this product as 4 out of 7, which is a medium risk class. This classification rates the potential losses from future performance at a medium level, and poor market conditions could affect the value of your investment. This classification is not guaranteed and may change over time and may not be a reliable indication of the future risk profile of the Fund. The lowest category does not mean risk free.
- **Be aware of currency risk.** If you receive payments in a currency that is different to the product's base currency, the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

- This product does not include any protection from future market performance so you could lose some or all of your investment.
- If the product is not able to pay you what is owed, you could lose your entire investment.

#### Investment performance information

- The Fund's asset allocation (i.e., mix of assets) that changes over time will drive investment performance. Given the growth focus, equities are likely to be the dominant driver of risk and return.
- A composite index ("Index") comprising Bloomberg Global Aggregate Corporate Index GBP Hedged, MSCI All Country World Index Gross GBP Hedged and MSCI All Country World Gross TR Index should be used to compare the performance of the Fund. The weighting given to the three sub-indices within the Index will be reviewed annually to ensure so far as possible that the expected volatility of the Index remains within a defined range, provided that the aggregate weighting to MSCI All Country World Index Gross GBP Hedged and MSCI All Country World Gross TR Index does not fall below 50%. The weighting will be reported to unitholders on a quarterly basis. The Fund volatility may be higher, lower or similar to the Index.

#### What could affect my return positively?

- The Fund's performance will be maximised when the global economy is strong as equity markets are widely expected to rise during such conditions. Equities are likely to be the dominant driver of risk and return for this Fund.

#### What could affect my return negatively?

- The most adverse scenario for this Fund could be when the global economy is on a downturn trend and equities, as the most dominant driver of risk/return for this portfolio, will contribute negatively to the portfolio performance.
- Under severe market conditions, it is expected that negative returns will be experienced across most asset classes and therefore the Fund is likely to experience losses. The investor redeeming under such adverse conditions may experience a financial loss due to negative performance, trading costs, and potential lack of liquidity.

#### What happens if BlackRock Fund Managers Limited is unable to pay out?

The assets of the Fund are held in safekeeping by its Depositary, Northern Trust Investor Services Limited ("NTISL"). The Depositary has delegated custody services to The Northern Trust Company, London Branch. In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on their behalf, or the insolvency of The Northern Trust Company, London Branch, the Fund may suffer a financial loss. In the event of the insolvency of the Manager or The Northern Trust Company, London Branch, you may be eligible for compensation under the Financial Services Compensation Scheme up to a maximum of £85,000 per claim. ## What are the costs?

### Presentation of costs
